#### 2. <u>Reservation of vacancies</u>:

- a) <u>SC/ST and OBC [NCL]</u>: Vacancies for SC/ST & OBC [NCL] candidates are reserved in accordance with Section 3A(1) & (2) and Section 3B (1) & (2) both of Chapter II of Apprentices Act-1961 read with Schedule II A of Rule 5 of Apprenticeship Rules 1992.
- b) <u>For Physically Handicapped</u>: 3% of vacancies for Apprenticeship training are reserved in accordance with Section 3.6.2 Chapter III of Apprenticeship Training Manual.

#### 3. Eligibility Condition:

- a) **Qualification**: Matric/Std. X with a minimum of 50 % [aggregate] marks for UR/OBC [NCL] candidates and 45 % [aggregate] marks for SC/ST candidates & ITI Examination in relevant Trade with aggregate of 60% marks qualified from **NCVT** [National Council for Vocational Training].
- b) <u>Age</u>: Minimum **18 years** and Maximum **25 years** as on 30.09.2019. Relaxation in upper age limits as per Government guidelines for SC/ST/ OBC [NCL] candidates.
- c) **Previous Training:** Candidates who have already undergone or are currently undergoing Apprenticeship training under Apprentice Act, 1961 in any Govt./Public Sector/Private Industrial organization **are NOT eligible to apply** for the current enrolment.
