UCIL shall be entitled to recover from the supplier costs incurred by UCIL in respect of the rejected goo ds. Rejected goods will be lying at the UCIL's store at the supplier's risk and shall be removed by the s upplier at his own cost immediately on receipt of rejected advice. The Corporation will not be responsi ble for any loss on account of deterioration etc. of the rejection goods. If rejected goods are not remov ed by the supplier, UCIL may charge penal rent and dispose of the goods as deemed.
