However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. - 3. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 4. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. - 1. Average Annual financial turnover during the last 3(Three) consecutive financial years, shall be at least 30% of the estimated cost supported by the audited annual accounts of each year.
- 2. Bidder shall have successfully executed/previous to similar work during last 7(seven) years ending last day of month which tender are invited (as per any one of the following):
 - a) Three(3) similar completed work each costing not less than the amount equal to 40% of the estimated cost

or

b) Two (2) similar completed works each costing not less than the amount equal to 50% of the estimated cost

c) One (1) similar completed work each costing not less than the amount equal to 80% of the estimated cost.

Similar work means:

Should have carried out excavation of earth/rock & RCC works for tunnel construction for road/mine. Or

Should have carried out excavation of earth/rock & RCC works for large earthen dam/bridge.

3. Necessary documentary evidences in support of the same in the form of copy of Work Orders & Completion Certificates from the competent authority of client, along with the contact details of the signatories shall be furnished, in absence of which the offer will be rejected. Any other document / certified drawing as desired by UCIL, to assess the Similar Work shall have to submitted.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents/clauses shall also be null and void. If any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
