ADDITIONAL TERMS AND CONDITIONS (ATC) AND SCOPE OF WORK

M/s Uranium Corporation of India Limited (hereinafter referred to as UCIL) have pleasure in enclosing the follow ing bid documents for the work and invite online bids from prospective bidders with the best & binding offer for Supply of Industrial Washing and Drying Machine along with its operation and maintenance for the period of 05 (Five) years as per the following:

SCOPE OF WORK

 Contractor has to supply install and maintain the industrial washing and drying machine along with its operation for the period of 05 (Five) years. Post completion of the work order the washing machine shall be the property (capital asset) of UCIL.

 \emptyset Washing Machine 50 kg capacity = 1 unit

- 2. Cost of washing and drying machine shall be reimbursed as per the quoted rate.
- 3. Installation of washing and drying machine shall be done by the contractor at his own cost.
- 4. Maintenance (including spares) of washing and drying machine shall be borne by the contractor for entire contract period. No extra cost shall be paid to the contractor in this respect.
- 5. Contractor has to maintain register for collecting and distribution of washed cloths on daily basis.
- 6. Contractor should create the facility of receive and issue of the cloths in the manner as desired by the ma nagement.
- 7. Any missing of cloths shall be accounted and recovered from the contractor's bill.
- 8. The cloths are to be dried to the extent for ready to wear.
- 9. All workers required for operating and maintaining the machine will be managed and paid by the contract or.
- 10. The washing facility has to be served to the requirement of Jaduguda, Bhatin and Bagjata Mines and shall be a managed by the contractor.
- 11. Post completion of job order Industrial Washing Machine and Drying Machine shall be the property of UCIL.

ELECTRIC POWER

Electric power will be made available to the contractor at 440 volts, 50 cycles, and 3 phases at the site at o ne fixed point. The required wiring, switches, starters etc required to operate the machines will have to be provided by the contractor. The electrical load required to operate the machines should be communicated well in advance to UCIL for creating the provision.

WATER

Water connection will be provided at one fixed point. The internal plumbing has to be provided by the contractor.

DRAINAGE

There will be one drain provided to the contractor. The Internal water draining arrangement has to be creat ed by the contractor.

WASHING POWDER

Washing powder shall be provided by the company at the rate of 10 grams per cloth.

SECURITY OF THE MACHINE

All property belongs to the contractor would be kept in secured way. UCIL management has no respon

sibility for any loss, damage of the equipment/property of the contractor.

CONTRACT PERIOD

This work will continue for the period of 5 years after commencement. The contract period may be ext ended / terminated at the direction of the management.

Contractor should hand over the clear site to the UCIL after completion of job after removing all the sur plus materials, spoils, debris etc. failing which UCIL has right to:

- a) Retain the Final bill till site clearance is completed,or
- b) Engage some other agency to carry out site clearance at your risk andcost.

The contractor shall carry out all the work up to a total variation of \pm 10% of the contract price and up to any extent on individual item. The tender rate shall remain firm within this limit and extra items may be included.

- The contractor should obtain necessary <u>General Insurance</u>, <u>ESI & Term Insurance</u> at his own cost for the whole period of the contract and shall be furnished to the corporation before commenc ement of the work without which contractor will not be allowed to start the work.
- The contractor has to issue photo pass to their labours engaged against the work with complete d
 etails of the labour and obtained Local Police verification duly signed by concern Security Officer of
 UCIL.
- 3. All the labour rules shall be followed strictly as per Contract Labour (Regulation & Abolition) Act, 1 970. All registers, forms stipulated under Minimum Wages (Central) Act should be maintained by th e contractor and to be furnished to the UCIL before commencement of the work. In case of non-sub mission of above registers/forms to the UCIL regularly, contractor will not be allowed to continue to do the work.
- 4. The required apron, shoes etc. will have to be provided to all the workers engaged by the Cont ractor at regular intervals. The Contractor shall ensure safety of his worker deployed for operating the machine.
- 5. The Minimum wage as per Governmentnotification is to be paid to all workmen engaged by th e contractor in the presence of Officer- In- Charge or his representative and obtain a "Pay ment Certificate" without which the R.A bill will not be released. Further the contractor shall maintain all the records and registers up to date under Contract Labour (Regulation and Abolition) Act 1970 for UCIL inspection.
- 6. E.P.F., Bonus, paid holiday, other taxes will be paid on actual basis.
- 7. All the Manpower requires to be deployed in this contract should enroll as members of Provident Fund and should be given the Universal Accounts Number (UAN).
- 8. No payment shall be made incase strike/stoppage of work and penalty claim may not be applicabl e.
- 9. The contractor has to issue photo pass to their workers engaged against the work with complete details of the workers and obtaining Police verification.
