- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Buyer Added Bid Specific ATC

#### 1. Tenderers are requested to submit following:

a)TENDER FEES: NIL, The cost of tender fee shall be paid through in the Form of DD drawn in favour of Ur anium Corporation of India Limited, payable at State Bank of India, Pulivendula (IFSC:0989), through any I ndian nationalized bank. Documentary evidence regarding tender document fee i.e. scan copy of the sam e must be uploaded along with part-I in GeM portal website.

b)EMD: Offers should be accompanied by an Earnest money deposit of Rs. 5000.00/- failing which the off er shall be rejected. E.M.D shall be by way of a Demand Draft payable at State Bank of India, Pulivendula (IFSC:0989) drawn in favour of Uranium Corporation of India Limited, through any Indian nationalized bank EMD shall not bear any interest. Bidder should attach the scan copy of DD along with their offer (part I). Su bsequently Demand draft shall be send through Courier/ Speed post to Electrical Mill. department in seale d envelope superscribing DEMAND DRAFT for EMD, Tender Ref.no. and due date before opening of part I, f ailing which offer will be Rejected. This EMD amount will be held by the Corporation until placement of ord er/ contract, and will bear no interest. It will be forfeited in the event of break of contract.

The units registered under "Single Point Registration Scheme of NSIC"/ "MSME" are eligible to get the ben efits of issue of the Tender document free of cost and Exemption from payment of Earnest Money Deposit (EMD) as per govt. notification subject to submission of valid NSIC/MSME registration for work contracts. . However, they will confirm acceptance for submission of security deposit in case of award of contract to them.

#### I. PRE-QUALIFICATION CRITERIA:

The Tenderer who wish to participate in the Tender shall fulfill the following Qualifying Criteria.

- 1. Experience of having similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following
- a. Three similar works each costing not less than the amount equal to Rs.114993/-

(or)

b. Two similar works each costing not less than the amount equal to Rs.143741/-

(or)

- c. One similar work costing not less than the amount equal to Rs.229985/-
- 2. Average annual financial turnover during the last 3 years ending 31 st March of the financial year ending with 31.03.2023, should be minimum of Rs.86245/-
- 3. Similar Work means "AMC/Maintenance /Repair of Thyssenkrupp elevators
- 4. The bidder should be OEM/authorized service centre of Thyssenkrupp elevators ( Now n amed as TK elevators India pvt ltd). Authorised service centre must submit supporting documents as a proof.

All the above documents must be uploaded in online tender as a proof.

#### Other conditions:

Bidder should submit these documents also, but they are not part of PQC

The bidder should submit his PAN card, GST registration, audited balance sheets and profit and los s statements of the last three financial years ending March 2023. If the financial turnover of one ye ar is exceeding the average turnover of three financial years, it will be also be considered and will get qualified as per PQC

#### **SECURITY DEPOSIT:**

The Amount of Security Deposit including the amount of Earnest Money shall be 10% of the awarded ue of work. Fifty percent of this amount shall have to be deposited as initial security deposit at the tin of execution of agreement including the amount deposited as Earnest Money.

In addition to the above, balance fifty percent of Security deposit shall be deducted from running bills. I the full amount of security deposit is realised / retained by the corporation.

Failure in carry out the awarded work shall entail forfeiture of the security deposit. Security deposit we be refunded without any interest on written request in duplicate to the Engineer-In-Charge after satisf tory completion of the work order. This will be released after successful completion of the work .

#### **PAYMENT TERMS:**

Contractor shall be paid as per the following schedule duly certified by the Engineer-in-charge of the ontractor bill: The payment shall be mad ewithin 30 days after successful certification of the bill by Engineer In charge. If all the relevant documents are not submitted during submission of bill. The bill will be eturned back without processing.

**PERIOD OF CONTRACT:** The contract period is for one Year from the date of tual commencement of work after successful site mobilization. Site mobilization is all have to be done within 15 days on receipt of LOI indicating contract price of the work. However, date of actual start of work shall be fixed by UCIL.

**Contract Agreement:** - Contract Agreement should be executed in prescribed f ormat on a non-judicial stamped paper before commencement of work within *o ne week* from the date of issue of work order / L.O.I. However, no payment will be made without execution of contract agreement.

**Indemnity:** Contractor will fully indemnify the corporation against all responsibility and whatsoever a rising out of accident/injury to contractor's workmen, third party or to corporation's personnel and properties

Insurance: The contractor has to submit work compensation insurance before commencement of work. Work commencement shall be done within 15 days from date of issue of work order or as per GeM rules. Required labour laws to be followed. On overall only 12 visits per year i.e one visit per mont h atleast and if required extra visits during breakdown as applicable.

### **Technical Scope of work( Gold Maintenance Agreement)**

- 1. **Schedule maintenance and Annual Inspection Service:** The bidder must provi de routine maintenance, examination and lubrication service to the elevators as per standards of maintenance of elevators during maintenance. The elevator should be maintained 12 times in a year( i.e monthly once) during normal business hours, Mon day through Saturday, 9.00AM to 5.00PM except scheduled holidays. The bidder must furnish the necessary lubricants and cleaning materials, including replacement of hydraulic fluid and machine gear oil. The bidder must annually test all safety devices in accordance with relevant safety standards which includes full load testing also. The bidder will arrange access for other traders to the lift wells, the lift pits and machinery rooms, for which no additional cost will be given at the time of routine maintenance services
- 2. **Stoppage, Malfunction, Special Service requests:** The bidder shall attend to st oppages and malfunctions, during normal working hours on normal working days, an d holidays which jeopardize passenger safety as reported by or for the UCIL to your c all centre for which no additional cost will be given. The breakdown problem should be attended within 24 hours once the complaint is raised to your call centre.
- Component Replacement: Through out the duration of this Agreement, TK Elevat orIndia Private Limited shall replace or repair, free of charge, the following range of c omponents for reasons related to normal wear and tear. Coverage shall be inclusive of, ropes, inverter systems, and controller parts to be inclusive of printed circuit boar ds, machine replacement is excluded however repair is included. Sub components in clusive of, rollers, , bearings, solenoids, coils, Line chock, brake shoe liners, Door Loc k contacts, contactors, relays, push buttons, door operator VVVF drive, car door safet y device limit switches, governor, hoist way doorlocks, indicators, and other minor m echanical parts shall also be included except as excluded elsewhere. Where escalato r, moving walks, or other passenger conveyance equipment is covered under the sco pe of this Agreement, controller parts to inclusive of printed circuit boards, steps, an d step chains, Subcomponents steps rollers, handrail bearing, safety switches, magn etic switches, combs (Plates)shall also be included for repair or replacement in all cas es related to normal wear and tear. Components will be furnished by the TK Elevator India Private Limited. Other things which are not mentioned shall be in the scope of t he contractor.
- 4. **Term:** The period of contract is 1 year
- **5. Safety:** The bidder must take all necessary safeties during maintenance as per rule s of elevator maintenance. The bidder shall be fully responsible for any occurrence of faults due to malfunction of elevator. The bidder shall take all necessary precautions while handing over the elevator after maintenance.
- 6. Load test of elevator to be conducted and a certificate to be submitted aft er testing during the AMC period.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
