1. Generic

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

3. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Bidder shall submit signed copy of Audited Annual Financial Reports for last 3 (T hree) consecutive financial years ending 31st March' 2023 (Balance Sheet and P rofit & Loss Account). The signed Balance Sheet and Profit & Loss Account furnis hed by Bidders for financial eligibility should clearly indicate the details of the M embership No. & Firm No. of the Chartered Accountant.

Scope of Work

Scope of Work involves Comprehensive Annual Maintenance Contract for a peri od of two years for following packaged type centralized air conditioning units in stalled at different location of Narwapahar Mine.

Comprehensive based annual maintenance contract shall be inclusive of installa tion, repairs and replacement of the spare parts without any extra cost and exp enses to the quarterly routine services, preventive maintenance and breakdown maintenance to the packaged type centralized air conditioning units in addition to covering smooth working of the units as listed above.

This contract includes replacement of faulty spares like compressors, relays, th ermostats, fan motors, power contractors, rewinding of motors, providing bearin g to motors, drive belt, gas charging as required etc along with attending compl aints and breakdown of all air conditioning units as stipulated above.

Technical Details and Terms & Condition

- Contractor shall depute OEM authorized service engineer / technically comp etent service engineer along with helpers to ensure proper upkeep of the pac kaged type centralized air conditioning units and quick resolution of the fault during the AMC period.
- 2) On award of work contract, all stipulated packaged type air conditioning unit at different location shall be handed over to successful contractor in working condition by UCIL. Subsequent to it, Contractor would prepare a taking over report of the above stipulated packaged type air conditioning unit and it shall be the responsibility of the contractor to make the packaged type air co nditioning unit work satisfactorily throughout the contract period, also to han dover to the department in working condition on expiry of contract. Any dam age to the units in the contract period including defect liability period due to improper maintenance practice to be rectified / replaced by the contractor without any extra cost and expenses.
- 3) Contractor shall be responsible to take all precautions to ensure safety of th e deputed manpower at work.
- 4) All the tools and tackles required for carrying out the job shall be in the sc ope of the contractor.
- 5) During comprehensive AMC, contractor shall carry out four numbers of rou tine services per year and one number of preventive (overhauling) mainten ance services per year. Report of maintenance has to be prepared and sub mit it too.
- 6) Contractor shall undertake to arrange genuine spare parts of the listed air conditioning units and when required. Also to ensure availability of the spar e parts in their stocks so that immediate replacement of spare parts could be done. In case spare part is not available to them, same shall be arrange

d within seven days.

- 7) Breakdown calls shall be attended free of costs whenever required.
- 8) Preventive maintenance (Overhauling) on yearly basis shall be as per indus try standard / maintenance manual of packaged type centralized air conditi oning unit.
- 9) Apart from the overhauling, Routine (Quarterly basis) maintenance may co ver the following as applicable.

a) Checking of all the electrical parts and wiring and repair of it. Oiling of all the moving parts.

b) Tightening of all screws, fasteners

c) Checking cooling effect and if it is found that gas is less the same has t o be topped up.

d) Cleaning / replacement (if required) of all filters.

e) Checking of microprocessor based control units and if found defective, repair / replacement of the same if necessary.

f) Checking and Repairing (if required) of damaged insulation of duct / pi ping

- g) Cleaning of complete unit with water / chemical and blower fan also.
- h) De scaling of condensers and chemical cleaning of cooling coils.

i) Checking of all other parts as required for smooth running and cooling of the system.

- 10) Contractor shall maintain log sheet which will include number of services p rovided during the contract period with the time and date of receipt as and when complaints are received and part of the equipment got repaired or re placed with its proper model number and necessary details.
- 11) Contractor shall be responsible for the verification of new parts before fitti ng to the removed parts from the EIC / EIC's representative. In case they no tice any part is missing same to be brought into the notice of EIC / EIC's rep resentative or otherwise responsibility shall be of contractor.
- 12) Defective compressors within contract period are to be replaced with new compressor and repairing of the old compressors is not permitted. Whenev er new compressors are used, contractor has to furnish invoice and warrant y card of new compressor suitable to air conditioning unit to the EIC. No ext ra charge shall be applicable for it.
- 13) All the consumable articles / parts required for repairs & maintenance shall be provided by the contractor at no extra charge to the UCIL.
- 14) Contractor shall provide minimum six months warranty for the replaced par ts from the date of such replacement / repair.
- 15) Successful bidder has to obtain insurance policy for its deployed manpower
- 16) Each complaints regarding non functioning of packaged type air

conditioning units has to be attended within 6 hrs from the time of reportin g the complaints.

- 17) In case of delay in attending to breakdowns to packaged type centralized ai r conditioner units, penalty shall be applied as per penalty clause.
- 18) In case of breakdown of units, such complaints must be attended within six hours of lodging of such complaint. However in case of requirement of c hange of spare parts, then complaints should be resolved within seven day s. In case unit is not getting repaired or an alternative system not supplied within 7 days from the time of failure reported, then UCIL reserves its right to get the same repaired by or replaced from any other contractor and the cost and expenditure incurred therein shall be recovered from the contract or.
- 19) Working hour of UCIL is 07:00AM to 05:00PM. No scheduled maintenance w ork has to be undertaken on closed holidays and beyond working hours on any day except by prior approval of EIC and EIC's representative.
- 20) Successful contractor shall provide mobile no / email id of concerned perso nnel where complaints could be reported.
- 21) <u>Security Deposit</u> : Total amount of Security deposit shall be limited to 10% of the awarded value of work. Fifty percent of this amount shall have t o be deposited as initial security deposit at the time of execution of agreem ent within 15 days from the date of award of contract. Mode of payment is clearly defined in Sr.No 9 under General terms and condition of contract att ached.

In addition to the above, further amount to the extent of the 5% of awarde d value of the work will be deducted from the Running Account bills by wa y of percentage deductions.

SPECIAL CONDITIONS OF CONTRACT

1. 1) **Period of the contract:**

The period of contract shall be for two year from the date of issue of Lol / Work Order whichever is earlier.

2. <u>Rate</u>:

a) Rate will be firm during the period of contract and no escalation in rat e shall be permissible during contract period.

b) Rate of each item shall be inclusive of all taxes. Hence total amount of work will be inclusive of all taxes.

3. **L1 party Decision:** Party who quotes lowest (L1) amount for total w ork, shall be declared L1 party.

4. **Payment Term:** 7 Running Bill and One final bill will be allowed.

5. **Defect liability period:** The defect liability period for the contract will be **Six** month from the date of completion of the total contract. Decision of Engineer in Charge will be final & binding to the Contractor.

- 6. Bidder must have their service centers or workshops within 25KM distance f rom our Narwapahar mine premises. Being outside 25KM range, bid subm itted by bidder shall be subjected to rejection.
- 7. **Transportation:** Transportation of any machines or parts i.e To & Fro to bidder's workshop shall be arranged by the bidder.
- 8. **<u>Penalty</u>** : Penalty shall be attracted at following conditions
 - a) Delay in attending breakdown of units will be charged @ Rs 250/- for every one day of delay.

b) Delay in carrying out of repair where change of spare parts is involve d within seven days of reporting complaints will attract @ Rs 500/- for e very one day of delay.

Cumulative penalty shall be subject to maximum 5% of total value of c ontract.

9. The special conditions given in this section shall supersede the condition s given elsewhere in these documents.
