1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

DOCUMENTARY EVIDENCE IN SUPPORT OF PAST PERFORMANCE AND PROJECT/ PAST EXPERIENCE CRITERIA: - In support of the claim of meeting this experience/ technical criterion, bidder must sub mit following documentary proof, failing which tenderer will be disqualified.

- a. Copy of relevant work order/ Purchase order/ Service order clearly mentioning nature of work/ S ervice, various components/ Items, period and value.
- b. Copy of completion/ execution/ client certificate issued by end user/ owner clearly mentioning r eference to relevant work order / Purchase order/ Service order, actual value of executed work an d actual date of completion.

Financial Eligibility Criteria

The Average annual financial turn over during the last 3 years, ending 31st March of the previous financial year, should be at least 101.20 lakh.

The bidder shall submit documentary evidence by way of copies of audited balance sheet includin g profit and loss account, necessary undertaking etc. along with bid, failing which tenderer will be disqualified.

- a. The average shall be compared with the minimum requirement to ascertain the eligibility status of the bidder.
- b. If any bidder does not submit the Turnover value for any of the 3 years, the bidder will not disqualify and instead shall consider all 3 years for computing the average assuming a value of "zero" for the year for which no information has been furnished by the bidder.

The eligibility is to be decided strictly based on documents submitted at the time of receipt of tend ers. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of poor response, with a view to increase the competition, admission of additional documents to meet the PQ – criteria may be allowed subject to the condition that

- a) 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- b) The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
- c) The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.

And the opportunity of submission of additional documents will be given to all the bidders.

The L1 bidder will be decided considering the entire quoted amount and value. However**the job** may be split on two parties in the ratio of 65% and 35% or any other suitable ratio. Pref erence will be given to the bidder who has quoted the lowest rate for awarding the major portion o f order and for the balance portion 2nd lowest bidder may be considered. 2 nd lowest bidder will be awarded balance work at the rate of L1 bidder.

In case L2 bidder does not agree to work at L1 rates, in that condition L3 may be called for negoti ation with the conditions that L3 should supply the quantity at L1 rate only and so on. If no any bi dder agrees to work at L1 rate then 65% quantity will be awarded on L1 bidder for 8 months (65% of total duration). Purchaser reserves the right to take decision for balance quantity. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो।बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
