Bidders are bound to accept the orders accordingly.

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 1 year before the bid opening date. Only su ch firms need tender who can produce satisfactory evidence that they have the necessary experience & fi nancial resources and organization to undertake such work as per criteria mentioned below.

- i) The Tenderer"s average annual turnover for the work during last 03 years, ending 31st March of the pre vious financial year, should be at least Rs. 3.02 Lakh in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer
