# 1. Service & Support

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 4. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. <u>Click here</u> to view the file

# **PRE-QUALIFICATION CRITERIA (PQC) FOR TENDERERS:**

Only such firms need to tender who can produce satisfactory evidence that they have the n ecessary experience & financial resources to undertake such work as per criteria mentione d below.

i) Experience of having successfully completed similar work in any Central / State Gov
t. Organization / PSU / Public Listed Company during last 07 years (ending month o f March prior to the bid opening) as indicated in the bid data sheet should be either of th e following:

# 6. Purchase Preference (Centre)

# 7. Payment
