## 2. Scope of Bidder:

Weekly rest and leave will be applicable as per respective act

  - b) Insurance of all employees for the entire tender duration as per respective act for underground mines premises as mentioned in special conditions of c ontract. ESIC is not applicable for underground work hence insurance comp onent is kept separately as reimbursable cost.
  - c) Ensure safety appliances and PPE for all engaged manpower for the entire tender duration by providing Safety PPE up to Rs.3000+GST per person per year.
  - d) Tools and tackles to be provided to all workmen up to a ceiling value of Rs 93314.75 Plus GST.
