- i) Average Annual financial turnover during last three years ending 31st March of the previous financial year, should be at least Rs. 91,934 /-.
- ii) Experience of having successfully completed similar works during last 7 years ending last day of the month previous to the one in which applications are invited should be either of the following:
- a) Three Similar completed works costing not less than an amount equal to Rs. 1,22,578 /-
- or
- b) Two similar completed works costing not less than an amount equal to Rs. 1,53,223 /-
