### **Annexure-III**

#### **TERMS AND CONDITIONS OF WORK**

**Validity of offer:** Offer should be valid for minimum 30 days.

**Payment Terms:** 50% advance payment will be released against the study value after acceptance of work order. Bill for the advance amount shall be claimed within 15 days of acceptance of work order based on which payment will be released. Rest amount (rest 50% of value) will be released after completion of work and submission of final report of study.

**Liquidated Damages:** Liquidated Damages (LD) shall be levied where reasons are attributable to bidder, for delays in execution of contract. LD shall be levied @0.5% per week or part thereof on the value of unfinished work for each week of delay subject to maximum of 5% of the total value of the contract (excluding taxes).

**Period of Contract:** Total period of the contract will be 3months from the date of disbursement of advance amount.

**Deliverables:** Draft copy of report shall be submitted to UCIL before finalization of report. However, Final report will be provided in soft copy (in pdf format) and three bounded copies of the study.
