- 1. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. - 6. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally

#### 10. Generic

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

### 11. Buyer Added Bid Specific ATC

- 1) **Guarantee / Warranty:** Tyre should be guaranteed / warranted for period of minimum 1000 hours successful running against manufacturing defects & fitme nt.
- 2) **Pro-rata Penalty:** In case the life obtained of the tyres is lower than the guar anteed life as claimed, a penalty amount will be deducted on pro-rata basis. Pro -rata penalty amount will be calculated on proportionate basis as per formula b elow:

Pro-rata penalty formula = (B/A)xC

Where.

- A = Original Tread depth of the tyre
- B = Remaining tread depth at the time of failure of tyre
- C= Cost of the tyre

Life of the tyres will be monitored and reports of life of tyre will be jointly prepar ed and signed on monthly basis by both in-charge of UCIL Mines and supplier's r epresentative. This report will be the basis for penalty deduction, if any.

- **Related party clause**: Subsequent to bid opening, if it is found that bids sub mitted by related parties in which there seems to be collusion are liable to be re jected. Parties are considered to be related if one party has ability to control th e other party or exercise significant influence over the other party in making fin ancial and / or operating decision.
