- 1. - iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

- **3. Related party clause**: Subsequent to bid opening, if it is found that bids sub mitted by related parties in which there seems to be collusion are liable to be re jected. Parties are considered to be related if one party has ability to control th e other party or exercise significant influence over the other party in making fin ancial and / or operating decision.
