Pre Qualification Criteria

1. The bidder should submit any previous purchase orders for any vertical Turbine pumps/Intake well pumps (or) its spares in the last 3 years ending

last day of the month previous to the one in which tender is floated to any reputed industry.

2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of Uranium Corporation Of India Limited payable at SBI Main Branch, Pulivenula.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

Disclaimer

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
