- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of

primary product having highest value should meet this criterion.

- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 100%(selected by Buyer) percentage of total OUANTITY.
- 8. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

3. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. Click here to view the file

4. Inspection

Nominated Inspection Agency: On behalf of the Buyer organization, any one of the following Inspection Agency would be conducting inspection of stores before acceptance:

Pre-dispatch Inspection at Seller Premises (applicable only if pre-dispatch inspection clause has been selected in ATC): Not Required

Post Receipt Inspection at consignee site before acceptance of stores: Inspection at UCIL site will be final

5. Certificates

6. Certificates

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

7. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of URANIUM CORPORATION OF INDIA LIMITED payable at State Bank of India Jaduguda/Jamshedpur.

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

8. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of URANIUM CORPORATION OF INDIA LIMITED payable at State Bank of India Jaduguda/Jamshedpur. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

9. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

10. Buyer Added Bid Specific ATC

Additional terms & conditions.

- 1) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 2) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
- 3) **Pre Contract Integrity Pact:** As per format enclosed.
- 4) **Earnest Money deposit.**: Bidders who are not exempted for EMD as per GEM exemption rule, has to upload scanned copy of EMD document and hard copy of the same must be sent within 05 days of bid end date to the following address:

- 5) **Scope of Work:-** Supply, Fabrication, Erection, Testing and Certification of TANKS as detailed under MATERIAL DETAILS & SCOPE OF WORK (as per Annexure 1 & 2) on constructed civil foundations at TURAMDIH Mill as per the detail given below:
 - a) Supply of Steel materials like SS Plates, Angles, and Channels etc. of only SAIL/JINDAL make required for complete work as per drawing enclosed with tender document. The Plate shall be of minimum 1.5 m wide x 5.0 m long. Other items shall be supplied in standard lengths.
 - b) Supply of all consumables like Welding & cutting electrodes, gas, grinding / cutting wheel

of approved make of UCIL.

- c) Supply, Fabrication, Erection, Surface treatment, Commissioning & Testing of Pipelines for transfer of Hydrogen peroxide, shall be carried out at our site. SS316 Hex. Head Bolts with Nuts & Teflon Gaskets of required sizes shall be in your scope. Pipeline drawing will be provided in-situe at the time of fabrication.
- d) Only Argon Arc process shall be used for all welding.
- e) Arranging all tools and tackles, safety items, ladders, scaffolding etc. required for the completion of the job.
- f) Arranging for all testing instruments and tools (like dye penetration test) for checking of welding quality.
- g) Unloading of the material with your own arrangement at our site shown by the corporation
- h) Arranging for plate bending machine and transport facility for shifting of man and material
- i) Fabrication of the tanks, tank covers, nipples for inlet/outlet/drain/overflow/ instrument mounting points etc. manholes, cover fixing supports, patch plates for supporting walkways, other transfer and maintenance arrangement inside the tanks etc. as per the supplied drawing and the site decision of the Engineer-in-charge. All nozzles specified in the drawing will be one end welded and other with Standard SS Flanges. Nozzle projection will be as per drawing.
- j) Passivation (Surface treatment) shall be carried out at our site for complete system including Tanks, additional pipe manifolds, pipes, valves, pumps etc. Reagents required for above shall be in your scope.
- k) Any other changes will be as per Minutes of Meeting & Subsequent correspondence.
- l) Removal of all scraps separately to designated area within 500 mtr range as directed by the Engineer-in-charge.
- 6) SCHEDULE OF WORK: The work will be completed strictly within Six months from the date of LOI/P.O. The bidder has to supply steel items as per scope of work for the full job within 30 days of the order.
- 7) **SCRAP REMOVAL:** Removal of all scraps separately to designated area within 500 mtr range as directed by the Engineer-in-charge.

8) TEST REPORT/DOCUMENTATION:

Party shall submit the following documents

- Material purchase certificate for all steel items from manufacturer or authorized dealer.
- · inspection/test reports of bought out items
- · inspection/test reports of third party.
- 9) **SPECIAL INSTRUCTION:** GA & details drawings bearing drawing Nos.: UCT-2/CHEM/TANK/46, are enclosed for guidance only. You shall verify the existing foundation, obstacles, working height etc. & then submit your offer.
- 10) **DEFECT LIABILITY PERIOD:** Defect Liability period for individual tank shall be twelve months from the date of handing over of individual tank. In case of defects if any, the defects shall be rectified at free of cost on "free at our site" basis within one month of information of the defect. In case of delay in attending the defect as stipulated above, the defect liability period shall get

automatically extended. This should be backed up by a bank guarantee for 3% of the order value valid for the warranty / defect liability period as per our proforma enclosed.

DEVIATION FROM NIT TERMS: You will forward separate list of deviation with respect to 11) the commercial terms & conditions point wise and will indicate your conditions against the deviation part.

Note:

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) All technical details in all respect & supporting documents as per Bid document.
- You shall submit detail planning for timely completion of the job like schedule of material supply, schedule of fabrication & erection, painting etc.
- 4) Deviations, if any from tender specifications, with details.
- 5) Tank shall be fabricated at UCIL site only.
- 6) Party shall submit Material test certificate of manufacturer or any NABL Certified Govt. approved lab for all the supplied SS Material. However UCIL will conduct test at our own lab & in case of any dispute, our lab result will be final & binding.
- 7) Testing and certification of tanks should be carried out by the certifying agency (like Lloyd registration etc.) at our site before handing over to UCIL. Party shall confirm the name of third party in their offer for approval of UCIL.
- Any other items or work not specifically mentioned above but required for the completion of fabrication, surface treatment and testing of the tanks will have to be arranged by bidder with no extra payment.
- 9) The tank shall be guaranteed for satisfactory performance for one year from the date of taking over. Any defect generated or noticed during one year from the date of handing over will have to be rectified by the bidder with no extra cost within 30 days of the information. In case of not rectifying the defect within the stipulated time, Corporation shall get the defect rectified at risk and cost of the supplier with no further correspondence.
- 10) The bidder shall have to submit programm for completion of the work and get it approved from Engineer-in-charge within 15 days from the date of receipt of Purchase Order.
- 11) Fabrication scrap will be the property of the Corporation.
- 12) Electricity and water will be provided by UCIL for free of cost.
- 13) The contractor will have to strictly follow the all Additional Terms and Conditions mentioned above.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
