1. 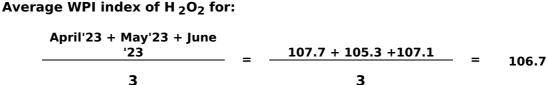

In case of any unforeseen situations arises in future regarding non availability or delisted o f Hydrogen per oxide in wholesale index price of economic advisor, in that case supply will be continues based on last supplied price calculated from website of WPI Index price of eco nomic advisor on preceding month till availability of the same on website of wholesale inde x price of economic advisor.
