3. **Definitions:**

- a) Corporation' shall mean Uranium Corporation of India Limited having it's register fice at Jadugoda Mines, Post office and Town Jadugoda Mines 832102, in the of Jharkhand and includes a duly authorized representative of the Corporation of the corporation of the corporation to discharge all or as a function.
- b) The `Accepting Authority' shall mean the authority mentioned in Schedule F.
- c) The `Contract' shall mean the notice inviting the tender, the tender, and acceptance thereof and all agreement, if any, executed between the Corporation and the Contractor together with the doct eferred to therein including these conditions, Designs, Drawings, Schedule of Quantities with rates ounts and Schedule of Rates. All these documents taken together shall be deemed to form one Cc nd shall be complementary to one another.

- 8.3 If on check there are found to be difference between the rates given by the Contractor in words and or in the amount worked out by him in the Schedule of Quantities and general summary the same sha usted in accordance with the following rules:
 - a) In the event of a discrepancy between description in words and figures quoted by a Tenderer, the ion in words shall prevail.
 - b) In the event of error occurring in the amount column of Schedule of Quantities as a result of wrong on of the Unit rate and quantity, the Unit rate shall be regarded, as firm and extension shall be am n the basis of the rate.
 - c) All errors in totalling in the amount column and carrying forwarded totals shall be corrected.
 - d) The totals of various sections of Schedule of Quantity appended and amended shall be carried over general summary and the tendered such amended accordingly. The tendered sum so altered shall purpose of the tenders be substituted for sum originally tendered and considered for acceptance in the original sum quoted by the Tenderer. Any rounding off of totals in various sections of Schedule tities or in general summary by the Tenderer shall be ignored.
 - e) In case of lump sum Contracts (based on bills of quantities/ quantity not shown as provisional), sly error in quantities or any omissions of items be discovered, the cumulative effects of which varies 000/- whichever is less, then the errors shall be rectified and the rectifications dealt with as for devariations under conditions 10 and 11 hereof, and the value thereof shall be added or deducted fror ntract sum, as the case may be, provided that there shall be no rectification of any errors, omissio ong estimates in the prices inserted by the Contractor in the Bills of quantities.

9. **Performance Security (Security deposit):**

Total amount of Performance Security shall be limited to 10 % of the awarded value of work. Fifty pe this amount shall have to be deposited as initial Performance Security at the time of execution of agree

- (a) Acceptable mode of payment of Initial Performance Security.
- i) For deposit up to Rs. 5000/-: Cash/Demand Draft payable at SBI or any other nationalized bank payable uda/Hartopa.

The said guarantee shall be valid till the expiry of ct liability period and issue of the final certificate by the Engineer, and with a claim period of Six months beyo quired validity.

In addition to the above, further amount to the extent of the 5% of awarded value of the work will be d from the Running Account bills by way of percentage deductions. Such percentage deduction shall % of the running account bills till the full amount of performance security is realized/retained by the C on.

(b) All compensation or other sums of money payable by the Contractor under the terms of this contact ther contact or any other account whatsoever may be deducted from or paid by sale of a sufficient payable performance security or from the interest arising there from or from any sums which may be due or leduce to the Contractor by the Corporation or any account whatsoever and in the event of his performaturity be reduced by reason of any such deduction or sale as aforesaid, the Contractor shall within four ys of receipt of notice of demand from the Engineer-in-charge make good the deficit.

(c) Refund of Performance Security (Security deposit):

Initial Performance Security shall be refunded to the Contractor on the Engineer-in-charge certifying ng that the work has been completed as per condition 31 hereof etc.

(d) On expiry of the Defects liability period (referred to in condition 33 hereof) or after payment of the Fire ayable whichever is later, the Engineer-in-charge shall on request from the Contractor refund to him to ining portion of the Performance Security provided the Engineer-in-charge is satisfied that there is no outstanding against the Contractor.

10. **Deviation/Variation Extent & Pricing**:

The Engineer-in-charge shall have power (i) to make alteration in, omissions from, additions to, or s on for the original specification, drawings design and instructions that may appear to him to be neces advisable during the progress of the work and (ii) to omit a part of the works in case of non availability rtion of the site or for any other reasons and the Contractor shall be bound to carry out the works in a ce with any instructions given to him in writing signed by the Engineer-in-charge and such alterations ons additions or substitutions shall form part of the Contract as if originally provided therein and any additional or substituted work which the Contractor may be directed to do in the manner above specil art of the works, shall be carried out by the Contractor on the same conditions in all respects including n which agreed to do the main work except as hereinafter provided. No work which radically change ginal nature of the Contract shall be ordered by the Engineer-in-charge as a deviation and in the even deviation being ordered which in the opinion of the Contractor changes the original nature of the Contract shall nevertheless carry it out and the disagreement as to the nature of the work and the rate to be part of the resolved in accordance with condition 52.

- 10.1 The time for completion of the works shall, in the event of any deviations resulting in additional cost e Contract sum being ordered, is extended as follows if requested by the Contractor.

In the event of the Contractor failing to inform the Engineer-in-charge within the s d period of time, the rate, which he proposes to claim, the rate for such item shall be determined b gineer-in-charge on the basis of market rate(s). for this purpose the purchase voucher etc. shall be ed by the Contractor to the Engineer-in-charge.

11. Suspension of works:

The Contractor shall on receipt of the order in writing of the Engineer-in-charge suspend the proce e works or any part thereof for such time and in such manner, as the Engineer-in-charge may consic ssary for and of the following reasons.

- i) On account of any default on part of the Contractor or
- ii) For proper execution of the works or part thereof for reasons other than the default of the C r; or
- iii) For safety of the works or part thereof.

12. TIME AND EXTENSION FOR DELAY:

The time allowed for execution of the works as specified in the Schedule - 'F' or the extended time, dance with these conditions shall be of the essence of the Contract. The execution of the work shall ce from the date of 15th day after the date on which the Engineer-in-charge issues written orders to ce the work or from the date of handing over the site whichever is later. If the Contractor commits deformencing the execution of the work as aforesaid, Corporation shall without prejudice to any other remedy be at liberty to forfeit the Earnest Money/Performance Security absolutely.

13.1 As soon as possible, after the Contract is concluded, the Engineer-in-charge and the Contractor shall pon a Time and Progress Chart. The Chart shall be prepared in direct relation to the time stated in the act Documents for completion of items of the work. It shall indicate the force of the dates of commen and completion of various trades or sections of the work and may be amended as necessary by agree tween the Engineer-in-charge and the Contractor within the limitation of time imposed in the Contractor, and further to ensure good progress during the execution of the work, the Contractor shall min all cases in which the time allowed for any work exceed one month (save for special jobs) complete the whole of the work before 1/4th of the whole time allowed in the Contract has elapsed 3/8th before such time has elapsed.

13.2 If the works be delayed by

- (a) Force major, or
- (b) Abnormally bad weather, or
- (c) Serious loss or damage by fire, or
- (d) Civil commotion, local combination of workmen, strike or engaged by Corporation in executiin not forming part of the Contract, or
- (e) Delay on the part of other Contractor or tradesman engaged by Corporation in executing wc forming part of the Contract, or
- (f) Non-availability of stores which are the responsibility of Corporation to supply, or
- (g) Non-availability or break-down of Tools and Plant to be supplied or supplied by Corporation o
- (h) Any other cause, which, in the absolute discretion of the Corporation, is beyond the Contract trol.

Then upon the happening of any such event causing delays, the Contract shall immediately go e thereof in writing to the Engineer-in-charge but shall nevertheless use constantly his best e s to prevent or make good the delay and shall do all that may be reasonably required to the s on of the Engineer-in-charge to proceed with the work.

- 13.3 Request for extension of time to be eligible for consideration shall be made by the Contractor in writ in fourteen days of the happening of the event causing delays. The Contractor may also, if practicable e, in such request, the period for which extension is desired.
- 13.4 In any such case, the Corporation may give a fair and reasonable extension of time for completion o rk. Such extension shall be communicated to the Contractor by the Engineer-in-charge in writing with nths of the date of receipt of such requests by the Engineer-in-charge.
- 14. The Contractor shall arrange at his own expenses all tools, plant and equipment (hereinafter refer to P) required for execution of the work.
- 14.1 If the Contractor required any item of T & P on hire from the Corporation, the Corporation will, if such available and the same can be spared, hire it to the Contractor at a rate to be fixed by the Engineer-ir

- 14.2 The period of hire will be reckoned from the commencement of the day of issue up to the end of the eturn (including all recognized holidays) irrespective of the actual hour of issue and return. The Contr II be exempt from levy of any charges for the number of days he is called upon in writing by the Engir harge to suspend execution of the work, provided Corporation's T & P in question has, in fact, remain with the Contractor because of the suspension, provided the Contractor, in case the period of suspensieds 11 days returns Corporation's T & P to the place from where the same was issued.

- 14.4 The Corporation give no guarantee in respect of output of his T & P hired to the Contractor and no rein rates or any compensation shall be allowed on the ground that outturn or performance of Corporati P was not to the Contractor's expectations.
- 14.5 Corporation's T & P hired to the Contractor shall be returned at the place of issue (unless otherwise) by the Contractor to the Engineer-in-charge on completion of the work or section of the work or earli rmination of the hire by the Corporation as hereinafter provided on a written notice by the Engineer-ir . The Corporation shall be entitled to terminate the hire on two days notice without assigning any re atsoever on account of termination of hire of Corporation's T & P by the Corporation. In such an even er, a reasonable extension of time shall be given by the Engineer-in-charge.
- 14.6 A Log Book for recording hours during which every item of Corporation's T & P issued to the Contract worked each day, shall be maintained by the member of the crew-in-charge thereof or any representation he Engineer-in-charge appointed in that behalf and shall be daily attested by the Contractor or his au agent. - 15(a)2 The Contractor shall at his own expense and without delay supply to the Engineer-in-charge samples rials proposed to be used in the works. The Engineer-in-charge shall, within seven days of supply of s or within such further period as he may require, intimate to the Contractor in writing, whether sample proved by him or not. If samples are not approved, the Contractor shall forthwith arrange to supply to gineer-in-charge, for his approval, fresh samples complying with the specifications laid down in the Co
- 15(a)3. The Engineer-in-charge shall have powers to require removal of all of the materials brought at site by tractor which are not in accordance with the Contract specifications or do not conform in character or to samples approved by him. In case of default on the part of the Contractor in removing rejected materials and in the event of the Contractor refusing to comply; he may cause the same to be supplied er. All costs, which may accrue upon such removal and/or substitution, shall be borne by the Contractor
- 15(a)4. The Contractor shall indemnify the Corporation servant or employee of the Corporation against any a aim or proceeding relating to infringement or use of any patent or design or any other charges which payable in respect of or any article or materials or part thereof included in the Contract. In the event laim being made or action being made or action being brought against the Corporation in respect of a matters as aforesaid, the Contractor shall furnish indemnity immediately, provided that such indemnity not apply when such infringement has taken place in complying with the specific directions/issued by poration. But the Contractor shall pay any royalties or other charges payable in respect of any such a amount so being reimbursed to the Contractor only if the use was the result of any drawing and/or specific directions.

15(b) Materials to be supplied by the Corporation:

Materials to be supplied by the Corporation are shown in Schedule - B which also stipulates quantul of issue and rate(s) to be charged in respect thereof.

- 15(b)1. If after acceptance of the tender, the Contractor desires the Corporation to supply any other materia materials may be supplied by the Corporation, if available, at rates to be fixed by the Engineer-in-Cha all on payment before the materials are issued to the Contractor.
- 15(b)2. For the materials listed in Schedule-B, which the Corporation has agreed to supply the Contractor, he e reasonable notice in writing about his requirements to the Engineer-in-charge in accordance with the displacement of programme. Such materials shall be supplied for the purpose of the Contract of aforesaid le, shall be set off or deducted, as and when materials are consumed in item of work for which payme ng made to the Contractor, or from any sums then due or which may after become due to the Contract m/under the Contract. At the time of submission of bills the Contractor shall properly account for the sissued to him to the satisfaction of the Engineer-in-charge and certify that balance of materials supply vailable at site.
- 15(b)3. The Contractor shall bear the cost of loading, transporting to site, unloading, storing under cover as reassembling and joining the several parts together as necessary, incorporating of fixing materials in the including all preparatory work of whatever description as may be required.
- 15(b)4. All materials issued to the Contractor by the Corporation for fixing in the works (including preparatory and being surplus on completion or on foreclosure of the work be returned by the Contractor at his explanate at wear and tear and/or waste. If the Contractor is required to deliver such materials at a place other explane of issue, he shall do so and the transportation charges from the site to such place, less the tration charges which would have been incurred by the Contractor had such materials been delivered at explanate explanate of issue, shall be borne by the Corporation.
- 15(b)5. Surplus materials returned by the Contractor shall be credited to him by the Engineer-in-charge at rat xceeding those at which these were originally issued to him after taking into consideration any deterr or damage which may have been caused to the said materials whilst in the custody of the Contractor.
- 15(b)6. If on completion of works the Contractor fails to return surplus materials out of these supplied by the (ion, then in addition to any other liability which the Contractor would incur, the Engineer-in-charge materite written notice to the Contractor require him pay within a fortnight of receipt of the notice, for such unsurplus materials at double the issue rates.

15(b)7. Delay in obtaining materials by the Corporation:

Owing to difficulty in obtaining certain controlled and other materials in the market, the Corporation dertaken to supply them as specified in Schedule - B, there may be delay in obtaining these materials Corporation and the Contractor is therefore, required to keep himself in touch with the day to day po garding the supply of materials from the Engineer-in-charge and to so adjust the progress of the work ir labour may not remain idle nor may there by any other claim due to or arising from delay in obtair materials. It should be clearly understood that no claim whatsoever shall be entertained by the Corp on account of delay in supplying materials.

15(c) **GENERAL**

Materials required for the works, whether brought by the Contractor or supplied by the Corporatior e stored by the Contractor only at places approved by the Engineer-in-charge. Storage and safe custo aterials shall be the responsibility of the Contractor.

15(c)1. Corporation official concerned with the Contract shall be at liberty any time to inspect and examine erials intended to the use in or on the works, either on the site or at factory or workshop or other placere such materials are assembled, fabricated, manufactured or any place(s) where these are lying or

ich these are being obtained and the Contractor shall give such facilities as may be required for such on and examination.

15(c)2. Materials supplied by the Corporation and brought to the site by the Contractor shall not be removed ite without the prior written approval of the Engineer-in-Charge. But whenever the works are finally c d, the Contractor shall at his own expense forthwith return to the all-surplus materials originally suppl m as per stipulation in the Contracts.

16. **LABOUR**

The Contractor shall employ labour in sufficient numbers to maintain the required rate of progress uality to ensure workmanship of the degree specified in the Contract and to the satisfaction of the Enc-Charge. The Contractor shall not employ in connection with the works any person who has not comps eighteen years of age.

- 16.1 The Contractor shall furnish to the Engineer-in-Charge at the intervals as decided by E.I.C., a distributio of the number and description by trades of the work, people employed on the works. The Contractor o submit on the 4th and 19th of every month to the Engineer-in-Charge a true statement showing in r f the second half of the preceding month and the first half of the current month (i) the accident that d during the said fortnight showing the circumstances under which they happened and the extent of c and injury caused by them and (ii) the number of female workers who have been allowed Maternity E s provided in the Maternity Benefit Act 1961 or Rules made there under and the amount paid to them
- 16.2 The Contractor shall pay to labour employed by him wages not less than fair wages as defined in the C Labour (Regulation & Abolition) Act, 1970 and Rules made there under.
- 16.3 The Contractor shall in respect of labour employed by him comply with or cause to be complied with the act Labour (Regulation & Abolition) Act, 1970 and Rules made there under in regard to all matters proherein.
- 16.4 The Contractor shall comply with the provision of the payment of Wages Act, 1936, Minimum Wages Act Employees Liability Act, 1938, Workmen's Compensation Act, 1923, Industrial Dispute Act, 1947, Mate nefit Act, 1961 and Mines Act, 1952 or any modifications thereof or any other Law relating thereto are made there under from time to time.
- 16.4(a) The Contractor shall be liable to pay his contribution and the Employees Contribution to the Employee nsurance scheme in respect of all labour employed by him for the execution of the Contract, in according the provision of `The Employees State Insurance Act, 1948' as amended from time to time and as applicable. In case the Contractor fails to submit full details of his account of labour employed and the tion payable, the Engineer- in-Charge shall recover from the running bills of Contractor an amount of to tion as assessed by him. The amount so recovered shall be adjusted against the actual contribution under Employees State Insurance scheme.
- 16.5 The Engineer-in-charge shall on a report having been made by an Inspecting staff as defined under the t Labour (Regulation) Act, 1970 and rules made there under have the power to deduct the money, due Contractor, any sum required estimated to be required for making good the loss suffered by a worker ers by reason of no fulfilment of the conditions of the Contract for the benefit of workers, non-paymen es or of deduction made from his or their wages which are not justified by the terms of the Contract o servance of the said act.
- 16.6 The Contractor shall indemnify the Corporation against any payment to be made under and for observ the Contract Labour (Regulation & Abolition) Act, 1970 and Rules made there under without prejudice ght to claim indemnity from his Sub-Contractors.
- 16.7 In the event of the Contractor committing a default or breach of any of the provisions of aforesaid Act a made amended/amended from time to time, or furnishing any information or submitting or filling any egister/Slip under the provisions of the Law which is materially incorrect, then on the report of the Ins Officer, the Contractor shall without prejudice pay to the Corporation a sum not exceeding liabilities f defaults including liquidated damages etc. for every default, breach or furnishing, making, submitting materially incorrect statement, as may be fixed by the Labour Department and the Contractor should fy the Corporation against all such liabilities.

16.7.1 Model Rules for Labour Welfare:

The Contractor shall at his own expense comply with or cause to be complied with Model Rules for Welfare as provided under the Rules framed by the appropriate government from time to time for the on of health and for making sanitary arrangements for workers employed directly or indirectly on the

n case the Contractor fails to make arrangements as aforesaid, the Engineer-in-charge shall be entitle so and recover the cost thereof from the Contractor.

Failure to comply with Model Rules for Labour Welfare, Safety code or the provisions relating to report dents and to grant Maternity Benefits to female workers shall make the Contractor liable to pay to the ation as liquidated damages an amount not exceeding Rs. 50.00 for each default on materially incorrement or reports from the Engineer-in-charge in such matters, based on reports from the Inspecting of all be final and binding and deductions for recovery of such liquidated damages may be made from the mount payable to the Contractor.

17. The Contractor shall not be permitted to enter on (other than for inspection purpose) or take posses he site until instructed to do so by the Engineer-in-charge in writing. The portion of the site to be occur the Contractor shall be defined and/or marked on the site plan, failing which these shall be indicated ngineer-in-charge at site and the Contractor shall on no account be allowed to extend his operations these areas.

In respect of any land allotted to the Contractor for purpose of or in connection with the Contract, tl actor shall be a licensee subject to the following and such other terms and the licenser may impose c s as:

- i) That he shall pay a nominal license fee of Rs. 1 per year or part of a year for use and occuparespect of each and every separate area of land allotted to him
- ii) That such use or occupation shall not confer any right of tenancy of the land to the Contract
- iii) That the Contractor shall be liable to vacate the land on demand by the Engineer-in-charge.
- iv) That the Contractor shall have no right to any construction over this land without the writter sion of the Engineer-in-charge. In case he is allowed to construct any structure he shall have lish and clear the same before handing over the completed work unless agreed to the Corpora
- 17.1 The Contractor shall provide, if necessary or if required on the site all temporary s there to and shall alter, adopt and maintain same as required from time to time hall take up and clear them away as and when no longer required and as and when ered by the Engineer-in-charge and make good all damage done to the site.

18. **SETTING OF THE WORKS**:

The Engineer-in-Charge shall supply dimensioned drawings, levels and other information necessary le the Contractor to set out the work. The Contractor shall provide all labour and setting out appliance ed and set out the work and be responsible for the accuracy of the same. 19. **SIDE DRAINAGE**:

All water, which may accumulate on the site during the progress of works or in trenches and excavaball be removed from the site to the satisfaction of the Engineer-in-charge and at the Contractor expe

20. NUISANCE:

The Contractor shall not at any time do, cause or permit any nuisance on the site or do anything who leaves unnecessary disturbance, inconvenience to owners, tenants or occupiers of other properties resite and to the public generally.

21. MATERIALS OBTAINED FROM EXCAVATION:

Materials of any kind obtained from excavation on the site shall remain the property of the Corporal shall be disposed of as the Engineer-in-charge may direct.

22. **TREASURE TROVE, FOSSILS ETC**.:

All fossils, coins, articles of value or antiquity and structures and other remains or things of geologi chaeological interest discovered on the site shall be the absolute property of the Corporation and the

25. **CONTRACTOR'S SUPERVISION - SUPERVISORY STAFF:**

The Contractor shall engage and keep at site, qualified technical staff/engineer with necessary suprupervisory staff of sufficient experience of all types of works covered by this Contract and they should I necessary authority to receive materials from the Corporation, issue valid receipt for the same, engage ur etc. and proceed with the work as required for speedy execution of the work.

26. **INSPECTIONS AND APPROVAL**:

All works embracing more than one process shall be subject to examination and a all at each stage thereof and the Contractor shall given due notice to the Engineer arge or his authorised representative when each stage is ready. In default of suce the Engineer-in-Charge shall be entitled to appraise the quality and extent there

- 26.1 No work shall be covered up or put out of view without the approval of the Engineer-in-charge or his zed representative and the Contractor shall afford full opportunity for examination and measurement work which is about to be covered up or put out of view and for examination foundations before permork is placed thereon. The Contractor shall give the notice to the Engineer-in-Charge or his authorized entative whenever any such work or foundation is ready for examination and the Engineer-in-charge presentative shall without unreasonable delay, unless he considers it unnecessary and advises the Conaccordingly; attend for the purpose of examining and measuring such work or of examining such foun In the event of the failure of the Contractor, such work shall be uncovered at the Contractor's expense mination by the Engineer-in-Charge.
- Corporation officers concerned with the Contract shall have powers at any time to inspect and exam part of the works and the Contractor shall give such facilities as may be required for such inspection mination.

27. DUTIES AND POWERS OF ENGINEER-IN-CHARGE'S REPRESENTATIVE

The duties of the Representative of the Engineer-in-Charge are to watch and supervise the works ar t and examine any materials to be used or workmanship employed in connection with the works. He ve no authority to order any work involving any extra payment by the Corporation or to make any var the works.

- The Engineer-in-charge may from time to time in writing delegate to his Representative any of the p nd authorities vested in the Engineer-in-charge and shall furnish to the Contractors a copy of all such delegation of powers and authorities. Any written instruction or written approval given by the Represof the Engineer-in-Charge to the Contractor within the terms of such delegation shall bind the Contractor the Corporation as though it had been given by the Engineer-in-charge.
- 27.2 Failure of the Representative of the Engineer-in-Charge to disapprove any work or materials shall no ice the power of the Engineer-in-Charge thereafter to disapprove such work or materials and to order own, removal or breaking up thereof.

27.3 If the Contractor shall be dissatisfied with any decision of the Representative of the Engineer-in-Char hall be entitled to refer matter to the Engineer-in-Charge who shall thereupon confirm, reverse vary s ision.

28. **REMOVAL OF WORKMEN**:

The Contractor shall employ in and about the execution of the works such persons as are skilled an enced in their several trades and Engineer-in-Charge shall be at liberty to object to and require the Contractor of the works any person employed by the Contractor in or about the execution of the who in the opinion of the Engineer-in-Charge misconducts himself or is incompetent or negligent in the performance of his duties and such person shall not be again employed upon the works without permethe Engineer-in-charge.

29. UNCOVERING AND MAKING GOOD:

The Contractor shall uncover any part of the works and/or make opening in or through the same as neer-in-charge may from time to time direct for his verification and shall re-instate and make good su o the satisfaction of the Engineer-in-charge. If any such part has been covered up or put out of view and approved by the Engineer-in-Charge and subsequently found on uncovering to be executed in account with the Contract, the expenses of uncovering and/or making opening or through reinstating and mal d the same shall be borne by the Contractor.

30. WORKING DURING NIGHT OR ON SUNDAYS AND HOLIDAYS

Subject to any provisions to the contrary contained in the Contract none of the permanent works slarried out during night or on Sundays or on authorized holidays without the permission in writing of the eer-in-Charge except when the work is unavoidable or absolutely necessary for the safety of life, programmers in which case the Contractor shall immediately advise the Engineer-in-charge accordingly.

31.1 **COMPLETION CERTIFICATE:**

As soon as the work is complete, the Contractor shall give notice of such completion to the Enginee ge and within ten days of receipt of such notice the Engineer-in-charge shall inspect the work and sha h the Contractor with a certificate of completion indicating (a) the date of completion, (b) defects to k ed by the Contractor and/or (c) items for which payment shall be made at reduced rates. If the Contractor shall fail to comp any of the requirements of this conditions as aforesaid, on or before the date of completion of the wo Engineer-in-charge may at the expense of the Contractor fulfill such requirements and dispose of the ngs, surplus materials, and rubbish etc. as he thinks fit and the Contractor shall have no claim in rest ny such scaffolding or surplus materials except for any sum actually realized by the sale thereof less t of fulfilling the requirements and any other amount that may be due from the Contractor, if the expen filling such requirements is more than the amount realized on such disposal as aforesaid the Contract forthwith on demand pay such excess.

- 31.2 If at any time before completion of the work, items or groups of items for which separate periods of ion have been specified, have been completed the Engineer-in-charge with the consent of the Contract spossession of any part of the same (any such parts being hereinafter in this conditions referred to a evant part) then not withstanding any thing expressed or implied elsewhere in this Contract.
- 31.2 (a) Within ten days of the date of completion of such items or group of items or of possession of the relevante Engineer-in-charge shall issue completion certificate for the relevant part as in conditions 31(1) e provided the Contractor fulfils his obligations under that condition for the relevant part.
 - (b) The Defects Liability Period in respect of such items and the relevant part shall be deemed to have need from the certified date of completion of such items or the relevant part as the case may be.
 - (c) The Contractor may reduce the value insured to extent of full value of the completed items or rele

t as estimated by the Engineer-in-charge for this purpose. This estimate shall be applicable for this e only and for no other.

(d) For the purpose of ascertaining compensation for delay in completion of the work relevant part w emed to form a separate item or group, with date of completion as given in the Contract or as exte der the relevant condition and actual date of completion as certified by the Engineer-in-charge und ondition.

32. **COMPENSATION FOR DELAY**

- (a) Liquidated Damages (LD) shall be levied where reasons are attributable to supplier / contractors for s in execution of purchase order/ contract. LD shall be levied @0.5% per week or part there of on the unfinished supply/work order for each week of delay subject to a maximum of 5% of the total value of t (excluding taxes and duties)

This aspect should be brought out in the tender docud. If it is equally applicable to import orders then suitable provision to this effect has to be made in the and L.C.
- (e) All the proposals for waiver of LD shall be vetted by concerned SPC/WTC.
- (f) The Unit heads are authorized to waive LD arising out of POs/WOs issued under their delegated por (g) In all other cases approval for waiver of LD shall be accorded by CMD and proposal need to be sen gh D (T)/D (F).

33. **DEFECTS LIABILITY PERIOD**

The Contractor shall be responsible to make good and remedy at his own expense within such peri ay be stipulated by the Engineer-in-charge, any defect which may develop or may be noticed before t y of the period mentioned in hereto from the certified date of completion and intimation of which has nt to the Contractor within seven days of the expiry of the said period by a letter sent by hand deliver egistered post. There will be 06 (Six) months defect liability period for this work

- 34. From commencement to completion of the works, the Contractor shall take full responsibility for the ereof and for taking precautions to prevent loss or damage and to minimize loss or damage to the gre tent possible and shall be liable for any damage or loss that may occur to the works or any part there I Government T & P from any cause whatsoever (save and except the Excepted Risks) and shall at his st repair and make good the same so that at completion of the work, Corporation's T & P shall be in g er and condition and in conformity in every respect with the requirements of the Contract and instruct he Engineer-in-charge.
- 34.1 Provided always that the Contractor shall not be entitled to payment unless the Contractor shall ins works (from commencement to completion), the Corporation's T & P hired by the Contractor and all m at site to their full value (as to Corporation's T & P according to the value indicated in Schedule-C), age risk or damage from whatever cause arising other than the Excepted Risks. The said insurance shall oint name of the Corporation and the Contractor, The Contractor shall deposit with the Engineer-in-chasid policy or policies. All money payable by the insurers under such policy or policies shall be recove he Corporation and shall be paid to the Contractor in instalments by the Engineer-in-charge for the puf re-building or replacement or repairs of the works and/or goods destroyed or damaged as the case no Provided however if the amount payable by the insurers in respect of any claim under such a policy is xcess of the amount mentioned in Schedule F the same may be recovered by the Contractor directly e insurers and shall be utilized by him for the purpose of re-building or replacement or repairs of the voldor goods destroyed or damaged as the case may be.
- 34.2 If the Contractor has blanket insurance policy for all his works and the policy covers all the items to ed under this condition, the said policy shall be assigned by the Contractor in favour of the Corporatic ded however, if any amount is payable under the policy by the insurers in respect of works other than k under this Contract, the same may be recovered by the Contractor directly from the insurers.
- Where the Corporation building or a part thereof is rented by the Contractor he shall insure the enting if the building or any part thereof is used by him for the purpose of storing or using materials of coenature, as to which the decision of the Engineer-in-Charge shall be final and binding.

- The Contractor shall indemnify and keep indemnified the Corporation against all losses and claims es or damage to any person or any property whatsoever which may arise out of or in consequence of struction and maintenance of works and against all Claims, demands, proceedings, damages, cost of ond expenses whatsoever in respect of or in relation thereto provided always that nothing herein contains all be deemed to render the Contractor liable for or in respect of or to indemnify the Corporation again compensation or damage caused by the Excepted Risks.
- The Contractor shall at all times Indemnify the Corporation against all claims, damages, or compen nder the provisions of payment of wages Act 1936, Minimum Wages Act 1948, Employer's Liability 38, The workmen's Compensation Act 1923, Industrial Disputes Act 1947, and Maternity Benefit Ac E.P.F and M.P. Act, 1952 or any modifications thereof or any other law relating thereto and rules made nder from time to time or as consequence of any accident or injury to any workmen or other persons out the works, whether in the employment of the Contractor or not, (save and except where such accinjury has resulted from any act of the Corporation, it's agents or servants) and against all cost, charge expenses of any suit action or proceedings arising out of such accident or injury and against all sum of which may with the consent of the Contractor be paid to compromise or compound any such claim, we miting his obligations and liabilities as above provided. The Contractor shall insure against all claims es or compensation payable under the Workmen's Compensation Act 1923 or any modification there y other Law relating thereto.
- The aforesaid insurance policy/policies shall provide that they shall not be cancelled till the Enginee ge has agreed to there
- 34.7 The Contractor shall prove to the Engineer-in-charge from time to time that he has taken out all the ce policies referred to above and has paid the necessary premiums for keeping the policies alive till e the Defect Liability Period, if any.
- 34.8 The Contractor shall ensure that similar insurance policies are taken out by his Sub-Contractors (if a shall be responsible for any claims or losses to the Corporation resulting from their failure to obtain a insurance protection in connection thereof. The Contractor shall produce or cause to be produced by -Contractors (if any) as the case may be, the relevant policy or policies and premium receipts as and quired by the Engineer-in-charge.
- 34.9 If the Contractor and/or his Sub-Contractor (if any) shall fail to effect and keep in force the insurance d to above or any other insurance which he/they may be required to effect under the terms of the Co hen and in any such case the Corporation may, without being bound to, effect and keep in force any urance and pay such premium or premiums as may be necessary for that purpose and from time to t uct the amount so paid by the Corporation from any money due or which may become due to the Corporation recover the same as debt due from the Contractor.

35. **FACILITIES TO OTHER CONTRACTORS**:

The Contractor shall, in accordance with requirement of the Engineer-in-charge, a all reasonable facilities to other Contractors engaged contemporaneously on separatracts in connection with the works and for departmental labour and labour of a her properly authorized authority or statutory body which may be employed at the on execution on any work not included in the Contract or of any Contract which the poration may enter into the connection with or ancillary to the works.

36. NOTICES TO LOCAL BODIES

The Contractor shall comply with and give all notices required under any governmental authority, in the trial tria

36.1 The Contractor shall pay and indemnify the Corporation against any liability in respect of any fees o s payable under any Act of parliament, state laws or any Government instrument, rule or order and a ations or by-laws of any local authority in respect of the works.

37. **SUB CONTRACTS**

The Contractor shall not sublet any portion of the Contract without the prior writted proval of the Accepting authority.

38. **INSTRUCTIONS AND NOTICES**

Subject as otherwise provided in this Contract, all notices to be given on behalf of the Corporation at their actions to be taken on its behalf may be given or taken by Engineer-in-charge or any officer for the being entrusted with the functions, duties and powers of the Engineer-in-charge.

- All instructions, notices and communications etc. under the Contract shall be given in writing and if registered post to the last known place of above or business of the Contractor shall be deemed to have served on the date when in the ordinary course of post these would have been delivered to him.
- The Contractor or his agent shall be in attendance at the site/ sites during all working hours and shantend the execution of the works with such additional assistance in each trade as the Engineer-in-chaconsider necessary. Orders given to the Contractor's agent shall be considered to have the same force her had been given to him.
- 38.3 The Engineer-in-charge shall communicate or confirm his instructions to the Contractor in respect of cution of work in a "Work site order Book" maintained in the office of the Engineer-in-charge and the (or or his authorized representative shall confirm receipt of such instruction by the Contractor, he shall ished a certified true copy of such instructions.

39. FORE CLOSURE OF CONTRACT IN FULL OR IN PART DUE TO ABANDONMENT OR REDUCT SCOPE OF WORK:

If at any time after acceptance of the tender, the Corporation shall decide to abar r reduce the scope of the works for any reason, whatsoever hence not require the e or any part of the work to be carried out, the Engineer-in-Charge shall give notic riting to that effect to the Contractor and the Contractor shall have no claim to an ment of compensation or otherwise whatsoever, on account of any profit or advar or which he might have derived from the execution of the works in full, which he derive in consequence of the fore closure of the whole or part of the works.

- 39.1 The Contractor shall be paid at Contract rates full amount for works executed at site, and in additior onable amount as certified by the Engineer-in-charge for the items hereunder mentioned which could tilized on the work to the full extent because of the foreclosure.
 - (a) Any expenditure incurred on preliminary site work e.g. temporary access roads, temporary uts, staff quarters and site office, storage, accommodation and water storage tanks.
 - (b) i) The Corporation shall have the option to take over Contractor's Materials or any part thereof rought to site or of which the Contractor is legally bound to accept delivery from suppliers (fc oration in or incidental to the work), provided however, the Corporation shall be bound to tak he materials or such portions thereof as the Contractor does not desire to retain. For material over or to be taken over by the Corporation, cost of such materials shall, however, take into a purchase price, cost of transportation and deterioration or damage which may have been ca materials whilst in the custody of the Contractor.
 - ii) For Contractor's materials not retained by the Corporation, reasonable cost of transportatior materials from site to Contractor's permanent stores or to his other works, whichever is less. ials are not transported to either of the said places, no cost of transportation shall be payable.
 - (c) If any materials supplied by the Corporation are rendered surplus, the same except normal shall be returned by the Contractor to the Corporation at rates not exceeding those at which

ere originally issued less allowance for any deterioration or damage which may have been ca ilst the materials were in the custody of the Contractor. In addition, cost of transporting such s from site to the Corporation stores if so required by the Corporation.

(d) Reasonable compensation for transfer of T & P from site to Contractor's permanent stores or ther works, whichever is less. If T & P are not transported to either of the said places, no cost portation shall be payable.

The Contractor shall if required by the Engineer-in-charge furnish to him books of account, wa s, time sheets and other relevant documents as may be necessary to enable him to certify the able amount payable under this condition.

40. TERMINATION OF CONTRACT FOR DEATH:

If the Contractor is an individual or a proprietary concern and the individual or the ietary dies and if the Contractor is a partnership in concern and one of the partne, then unless the Accepting Authority is satisfied that the legal representative of t vidual Contractor or of the proprietor of the proprietary concern and in the case o ership, the surviving partners, are capable of carrying out and complete the Contract he Accepting Authority shall be entitled to cancel the Contract as to its incomplete without the Corporation being in any way liable to payment of any compensation estate of the deceased Contractor and/or to the surviving partners of the Contract rm on account of the cancellation of the Contract. The decision of the Accepting at the the legal representatives of the deceased Contractor or the surviving partners the Contractor's firm cannot carry out and complete the Contract shall be final an ing on the partners. In the event of such cancellation the Corporation shall not he estate of the deceased Contractor and/or the surviving partners of the Contractor liable in damages for not completing the Contract.

41. CANCELLATION OF CONTRACT IN FULL OR IN PART:

If the Contractor:

- a) At any time makes default in proceeding with the works with due diligence and continued to do s notice in writing of 7 days from the Engineer-in-charge or
- b) Commits default the works or items of work with individual dates of completion, and does not conhem within the period specified in notice given in writing in that behalf by the Engineer-in-charge.
- c) Fail to complete the works or items of work with individual dates of completion, and does not conhem within the period specified in notice given in writing in that behalf by the Engineer-in-charge.
- d) Shall offer or give or agree to give to any person in Corporation's service or to any other person ehalf consideration, any gift or of any kinds as an inducements or reward for doing or forbearing t having done or forborne to do any act in relation to the obtaining or execution of this or any othe ct for the Corporation.
- e) Shall enter into a Contract with the Corporation in connection with which commission has been progreed to be paid by him or to his knowledge, unless the particulars of any such commission and the payment thereof have previously been disclosed in writing to the Accepting Engineer-in-charge.
- f) Shall obtain a Contract with the Corporation as a reward offering tendering or by other non bonthods of competitive tendering or
- g) Being an individual, or if a firm any partner thereof, shall at any time be adjusted insolvent or h ceivers order for administration of his estate, made against him or shall take any proceeding, liqu or composition (other than a voluntary liquidation for the purpose of amalgamation or reconstruct er any Insolvency Act for the time being in force or make any conveyance or assignment of his ef composition or arrangement for the benefit of his creditors or purpose so to do, or if any applicati ade under any Insolvency Act for the time being in force for sequestration of his estate or if a trus e executed by him for benefit of his creditor, shall be given to the Contractor for value of the worl ed by him up to the time of cancellation, the value of Contractor's materials taken over and incorr n the work, and use of tackle and machinery belonging the Contractor work or
- h) Being a Corporation, shall pass a resolution or the Court shall make an order for the liquidation of rs, or a Receiver or Manager on behalf of the debenture holders shall be appointed or a circuit shall arise which entitle the court or debenture holders to appoint a Receiver or Manager or
- i) Shall suffer an execution being levied on his goods and allow to be contained for a period of 21 d

j) Assigns, transfers, sublets (engagement of labour on a piece basis or of labour with materials n incorporated in the work, shall not be deemed to be subletting) or attempts to transfer or sublet t e works or any portion thereof, without the prior written approval of the Accepting Authority.

The Accepting Authority may, without prejudice to any other right to remedy, which shall have a or shall accrue thereafter, the Corporation by written notice cancel the Contract as a whole or only ems of work on default from the Contract.

- 41.1 The accepting authority shall on such cancellation have power to
 - (a) Take possession of the site and any materials, constructional plant, implements, stores etc. there /or
 - (b) Carryout the incomplete work by any means at the risk and cost of the Contractor.
- On cancellation of the Contract in full or in part, the Engineer-in-Charge shall determine what amour , is recoverable from the Contractor for completion of the works or part of the works or in case the wo rt of the works is not to be completed, the loss or damage suffered by the Corporation. In determining ount, credit shall be given to the Contractor for the value of the work executed by the Contractor upto e of cancellation, the value of Contractor's materials taken over and incorporated in the work, and use e and machinery belonging to the Contractor.
- 41.3 Any excess expenditure incurred or to be incurred by the Corporation in completing the works or pa works or the excess loss or damages suffered or may be suffered by the Corporation as aforess allowing such credit shall be recovered from any moneys due to the Contractor on any account, and if oneys are not sufficient the Contractor shall be called upon in writing to pay same within 30 days.

If the Contractor shall fail to pay the required sum within the aforesaid period of 30 days, the Enginee ge shall have the right to sell any or all of the Contractor's unused materials, constructional plant, Im s, temporary building etc. and apply the proceeds of sale thereof, towards the satisfaction of any sum om the Contractor under the Contract and if thereafter there be any balance outstanding from the Contract shall be recovered in accordance with the provisions of the Contract.

Any sums in excess of the amounts due to the Corporation and unsold materials, constructional pla hall returned to the Contractor, provided always that if cost or anticipated cost of completion by the C on of the works is less than the amount which the Contractor would have been paid had he completec ks or part of the works, such benefit shall not accrue to the Contractor.

42. LIABILITY FOR DAMAGE/DEFECTS OR IMPERFECTIONS AND RECTIFICATION THEREOF:

If the Contractor or his workmen or employees shall injure or destroy any part of 1 Iding in which they may be working or any building, road, fence etc. contiguous to remises on which the work or any part of it is being executed or if any damage sh ppen to the work while in that progress, the Contractor shall upon receipt of a not writing in that behalf make the same good at his own expense. If it shall appear to Engineer-in-charge or his representative at any time during construction or re-cor ion or prior to the expiration of the Defects Liability Period, that any works has be ecuted with unsound, imperfect or unskilful workmanship or that any materials ar inferior quality to that Contract for, or otherwise not in accordance with the Contr that any defect, shrinkage or other fault have appeared in the work arising out of ive or improper materials or workmanship, the Contractor shall, upon receipt of a in writing in that behalf from the Engineer-in-Charge, forthwith rectify or remove construct the work so specified in whole or in part, as the case may require or as se may be and/or remove the materials or articles at his own expense not withsta that the same may have been to do so within the period to be specified by the En -in-charge, may rectify or remove and re-execute the work and or remove and rej with other materials or articles complained of, as the case may be, by other mear he risk and expense of the Contractor.

In case of repairs and maintenance works, splashes and droppings from white wa

painting, etc. shall be removed and surface cleaned simultaneously with completi these items of work in individual rooms, quarters or premises etc. where the work ne, without waiting for completion of all other items of work in the Contract. In ca Contractor fails to comply with the requirements of this condition, the Engineer-in ge shall have the right to get the work done by other means at the cost of the Color. 44. **CHANGE IN CONSTITUTION:**

Where the Contractor is a partnership firm, prior approval in writing of the accepting authority shall ined before any change is made to the constitution of the firm. Where the Contractor is an individual du Undivided Family-business concern, such approval as aforesaid shall likewise be obtained before the actor enters into any partnership agreement where under the partnership, firm would have the right out the work hereby undertaken by the Contractor. If prior approval as aforesaid is not obtained, the tight shall be deemed to have been assigned in contravention of condition 41(j) hereof and the same active taken and the same consequences shall ensure as provided for in the said condition 41.

45. TRAINING OF APPRENTICES:

PRE CONTRACT INTEGRITY PACT

WHEREAS the BIDDER is a private company / public company / Government undertaking / partnership / registered export agency, constituted in accordance with the relevant law in the matter and the BUYER is a PSU.

NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence / prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to:-

Enabling the BUYER to obtain the desired said stores/equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary Impact of corruption on public procurement, and

Enabling BIDDERS to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the BUYER will commit to prevent corruption, in any form, by its officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

Commitments of the BUYER

- 1.1 The BUYER undertakes that no official of the BUYER, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immediate benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the contract.
- 1.2 The BUYER will, during the pre-contract stage, treat all BIDDERS alike, and will provide to all BIDDERS the same information and will not ;provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS
- 1.3 All the officials of the BUYER will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.
- 2 In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the BUYER will full and verifiable facts and the same is prima facie found to be correct by the BUYER, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the BUYER and such a person shall be debarred from further dealings related to the contract process. In such a case while an enquiry is being conducted by the BUYER the proceedings under the contract would not be stalled.

Commitments of BIDDERS

- 3 The BIDDER commit itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the followings:-
- 3.1. The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 3.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the BUYER or otherwise in

procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract for showing or forbearing to show favour or disfavor to any person in relation to the contract or any other contract.

- 3.3 The BIDDER further confirms and declares to the BUYER that the BIDDER has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the BUYER or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
- 3.4 The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the BUYER or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 3.5 The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 3.6 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- 3.7 The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the BUYER as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- 3.8 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 3.9 The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 3.10 If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is a relative of any of the officers of the BUYER, or alternatively, if any relative of an officer of the BUYER has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of fill of tender.

The term 'relative' for this purpose would be as defined in Section 6 of the Companies Act 1956

- 3.11 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee of the BUYER.
- 4 Previous Transgression:

- 4.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public Sector Enterprise in India or any Government Department in India that could justify BIDDER's exclusion from the tender process.
 4.2 The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such
- 5 Earnest Money (Security Deposit)

reason.

- 5.1 While submitting commercial bid, the BIDDER shall deposit an amount ______ (to be specified in RFP) as Earnest Money / Security Deposit, with the BUYER through any of the following instruments:
- (i) Bank Draft or a Pay order in favour of
- (ii) A confirmed guarantee by an Indian Nationalized Bank, promising payment of the guaranteed sum to the BUYER on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the BUYER shall be treated as conclusive proof of payment.
- (iii) Any other mode or through any other instrument (to be specified by the RFP).
- 5.2 The Earnest Money / Security Deposit shall be valid upto complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and the BUYER.
- 5.3 In case of the successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of Sanctions for Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 5.4 No interest shall be payable by the BUYER to the BIDDER on Earnest Money / Security Deposit for the period of its currency.
- 6 Sanctions for Violations
- 6.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the followings actions, wherever required:-
- (i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.
- (ii) The Earnest Money Deposit (in pre-contract stage) and/or Security Deposit / Performance

Bond (after the contract is signed) shall stand forfeited either fully or partially, as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.

- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by the BUYER, and in case of an Indian BIDDER with interest thereon at 2% higher than the prevailing Prime Lending Rate of State Bank of India, while in case of BIDDER from a country other than India with interest thereon at 2% higher the LIBOR. If any outstanding payment is due to the BIDDER from the BUYER in connection with any other contract for any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- (v) To encash the advance bank guarantee and performance bond / warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER, along with interest.
- (vi) To cancel all or any other Contracts with BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such cancellation / rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER. (vii) To debar the BIDDER from participating in future bidding processes of Indian Rare Earths

 Limited for a minimum period of five years, which may be further extended at the discretion of the
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with the BIDDER, the same shall not be opened.
- (x) Forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 6.2 The BUYER will be entitled to take all or any of the actions mentioned at Para 6.1 (i) to (x) of this Pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.
- 6.3 The decision of the BUYER to the effect that a breach of the provisions of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact.

7 Independent Monitors

UCIL.

7.1 The BUYER has appointed Independent Monitors (hereinafter referred to as Monitors) for this Pact in consultation with the Central Vigilance Commission (Names and Addresses of the

Monitors to be given).

- 7.2 The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this Pact.
- 7.3 The Monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.
- 7.4 Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.
- 7.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the BUYER.
- 7.6 The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the BUYER including that provided by the BIDDER. The BIDDER will also grant the Monitor upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- 7.7 The BUYER will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.
- 7.8 The Monitor will submit a written report to the designated Authority of BUYER with 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

8 Facilitation of Investigation

In case of any allegation of violation of any provision of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

9 Law and Place of Jurisdiction

This pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the BUYER.

10 Other Legal Actions

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

11 Validity		
11.1 The validity of this Integrity Pact shall be from date of its signing and upto the complete		
execution of the contract to the satisfaction of both the BUYER and the BIDDER/Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire		
11.2 Should one or several provisions of this Pact turn out to be invalid, the remainder of this Pac		
shall remain valid. In this case, the parties will strive to come to an agreement to their original		
intensions.
