1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Forms of EMD and PBG

ATC (Additional Terms and Conditions)

1. Uniform:

The deployed manpower will be provided uniform, Safety Shoes by the concerned contractors and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt as given hereunder:

- 1. Uniform @ Rs. 1500 per person per year
- 2. Safety Shoes @ Rs. 500 per person per year

2. Medical Checkup

All the workmen to be deployed should go through proper medical checkups as mentioned in SLA (Special Conditions of Contract clause no. 17 page no. 12) and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt as given hereunder:

- Cost of Medical Checkup @ Rs. 1000 per person
- 3. Retrenchment Benefit

In case an employee has completed 240 days then he will be entitled to 15 days retrenchment compensation besides one month's salary in lieu thereof as if he has worked for one year.

Retrenchment compensation @ minimum wages of 15 days without any deduction and the expenditure

towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

4. National Holiday

As per Labour Laws the employers should provide paid day off for the three national holidays. If the employee work on these days then they will be paid double of their minimum wages on that holiday and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

5. Tools & Tackles

The L1 bidder have to provide tools & tackles of approx. Rs. 20,000/- as per the requirement and instruction of Engineer-In-Charge and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

The tools and tackles provided by the contractor as per the estimated amount of Rs. 20,000/- against the tender will be company's asset after completion of the contract.

Pre Oualification Criteria

1.0 ELIGIBILITY CRITERIA

The Tenderer who wish to participate in the tender shall fulfil the following eligibility criteria.

1.1 Technical Eligibility Criteria

The bidder should have experience of having successfully completed similar works during last 07 years last day of month previous to the one in which applications are invited should be either of the following:

- a. One similar work costing not less than Rs. 22.87 Lakhs.
- b. Two similar works each costing not less than Rs. 14.29 Lakhs.
- c. Three similar works each costing not less than Rs. 11.43 Lakhs.

Similar Work means having experience in "Supply of Manpower for Mechanical Works/ Auto Electrical Works of repairing and maintenance of diesel vehicles and equipments".

To support their experience criteria, bidder should submit copies of relevant Contracts & Agreements, along with evidence in respect of satisfactory execution of each of those contracts, in the form of copies of any of the documents (indicating respective contract number and type of services), such as

- a. Satisfactory completion/ performance report. In case work is continuing at the time of bidding, then bidder should submit satisfactory performance certificate from the existing client for executed work period & contract value (or)
- b. Proof of release of performance security after completion of the contract (or)
- c. Proof of settlement/ release of final payment against the contract (or)

- d. Any other documentary evidence that can substantiate the satisfactory execution of each the contract cited.
- e. If time period of two or more contracts are overlapping then common period will be considered as one period only.

2.0 Financial Eligibility Criteria

The average annual financial turnover of the bidder during last 03 (three) consecutive financial years ending 31st March 2022 shall not be less than Rs. 8.57 Lakhs.

Bidder shall submit signed copy of Audited Annual Report for last 03 (three) consecutive financial years ending 31st March 2022 (Balance Sheet and Profit & Loss Account). The signed Balance Sheet and Profit & Loss Account furnished by Bidder for financial eligibility should clearly indicate the details of the Membership No. & Firm No. of the Chartered Accountant.

In case Bidder is not able to submit the above, for genuine reason to be specified in writing, Chartered Accountant's Certificate, in original, may be submitted to substantiate the financial eligibility. The Chartered Accountant's Certificate should clearly indicate the detail of the Membership No. & Firm No. of the Chartered Account and the UDIN.

3.0 GEOGRAPHIC PRESENCE:

Office registration certificate: Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits of Jharkhand State where the services need to be provided.

Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- i. Trade License issued by the local authority in the name of the Firm or
- ii. Landline phone number in the name of the Firm or
- iii. Electricity bill for last one year in the name of the Firm or
- iv. GSTIN registration or
- v. Udyam/MSME/Udyog Aadhaar Certificate.
- 4.0 EPF registration copy, GSTIN copy, PAN copy must be submitted along with the bid.
- 5.0 Any bid not complying PQC requirements shall be summarily rejected.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents/clauses

shall also be null and void. If any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations. Also, GeM does not permit collection of Tender fee / Auction fee in case of Bids / Forward Auction as the case may be. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.

This Bid is governed by the <u>General Terms and Conditions</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
