The Tenderer who wish to participate in the tender shall fulfil the following eligibility criteria.

#### 1.1 <u>Technical Eligibility Criteria</u>

The bidder should have at least 01 (one) no. similar completed work experience during last 05 years last day of month previous to the one in which applications are invited should be either of the following:

Similar Work means having experience in "Supply of Manpower for Mechanical repairing and maintenance works of diesel vehicles and equipments".

To support their experience criteria, bidder should submit copies of relevant Contracts & Agreeme nts, along with evidence in respect of satisfactory execution of each of those contracts, in the form of copies of any of the documents (indicating respective contract number and type of services), su ch as

### 2.0 Financial Eligibility Criteria

The average annual financial turnover of the bidder during last 03 (three) consecutive f inancial years ending 31<sup>st</sup> March 2022 shall not be less than Rs. 11.19 Lakhs.

Bidder shall submit signed copy of Audited Annual Report for last 03 (three) consecutive financial y ears ending 31<sup>st</sup> March 2022 (Balance Sheet and Profit & Loss Account). The signed Balance Sheet and Profit & Loss Account furnished by Bidder for financial eligibility should clearly indicate the det ails of the Membership No. & Firm No. of the Chartered Accountant.

#### B.0 GEOGRAPHIC PRESENCE:

Office registration certificate: Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits of Jharkhand State where the services need to be provided.

The deployed manpower will be provided uniform, Safety Shoes by the concern ed contractors and the expenditure towards the same will be reimbursed to the m by the corporation on submission of documents / proof of receipt as given her eunder:

- i. Uniform @ Rs. 1500 per person per year
- ii. Safety Shoes @ Rs. 500 per person per year

#### 2. Retrenchment Benefit

In case an employee has completed 240 days then he will be entitled to 15 days retrenchment compensation besides one month's salary in lieu thereof as if he has worked for one year.

Retrenchment compensation @ minimum wages of 15 days without any deduction and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

### 3. National Holiday

As per Labour Laws the employers should provide paid day off for the three nati onal holidays in a year. If the employee works on these days then they will be p aid double of their minimum wages on that holiday and the expenditure toward s the same will be reimbursed to them by the corporation on submission of doc uments / proof of receipt.

### 4. Tools & Tackles

The L1 bidder have to provide tools & tackles of approx. Rs. 20,000/- a s per the requirement and instruction of Engineer-In-Charge and the exp enditure towards the same will be reimbursed to them by the corporation on su bmission of documents / proof of receipt.
