#### The eligible criteria to qualify in Techno commercial Part are as below:-

- Average Annual financial turnover during the last 3(Three) consecutive financial years, ending on 31.
   03.2022, shall be at least 30% (10.92 Lakhs) of the estimated cost supported by the audited annual accounts of each financial year.
- 2. Bidder shall have successfully completed similar works during last 7 (Seven) years ending on 31.0 3.2023 as per any one of following:
  - a) Three(3) similar completed works costing not less than the amount equal to 40% (14.55 la khs) of the estimated cost

or

b) Two (2) similar completed works costing not less than the amount equal to 50% (18.20 lak hs) of the estimated cost

or

- c) One (1) similar completed works costing not less than the amount equal to 80% (29.12 lak hs) of the estimated cost.
- 3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.
- 4. Similar works means "Experience in Any type of Civil Construction work or Civil Maintenance w ork in Public Sector Unit/ State Government Departments/ Central Government Department s."

#### **5. SCOPE OF WORK**

The scope of this Bid will be generally as per specification, working drawings, schedule of quantiti es and general / special conditions of contract and as directed by Engineer in charge, on behalf of Corporation. However minor construction work covered complete in all respect including finishing under this contract are as follows:

- (a) Supply of 03 nos. of Semiskilled manpower for pump operation (Daily basis including Rest day and Holiday) at Jahersthan area at Jaduguda tailing Dam. (01 reliever on rotation basis
- (b) Supply of 03 nos Unskilled manpower for miscellaneous work at Jaduguda tailing pond da m.
- (c) Maintenance of tailing pipe line including dismantling, laying and shifting the pipe line.
- (d) Removing cattle from tailings pond area for smooth operation.
- (e) Transporting, fixing, the sleeper in spillway channel at both ends.
- (f) Cleaning, washing the jammed pipes and drain cleaning, Grass cutting and Road preparat ion and various type of job related to tailing Dam.
- (g) All tools and tackles to be arranged by the Contractor at own cost. Cleaning, wire brushin g, removing rust or dust, spillage or any other chemical over pipeline.
- (h) Pump operation should be round of clock (all 03 shifts A, B, C), and Unskilled labour to b e supplied normally in G-shift and in case of emergency whenever required (in any Shift) a s per work requirement.
- (i) Medical and Height pass from UCIL Safety department of all workers engaged in painting work is a must requirement and without this work cannot be started.
- (j) All temporary work for execution of the work like construction of go down, temporary road et c, No separate payment will be paid for this work.

- (k) Any equipment, material or services which are not mentioned in the Bid document but required for completion of the work in safe and efficient manner shall be deemed to be included
- **<u>6. Penalty:</u>** Penalty Clause will be imposed on pro-data basis for short supply of manpower than 03 (Thr ee) manpower including both "semiskilled in any shift and unskilled in General shift" on day-to-day supply as follows:-

i)03 (Three) and above manpower supply in a working day (including all shifts) – No penalty.

ii)Below 03 (Three) up to 01 (Two) manpower supply in a working day (including all s hifts) – Penalty will be imposed 3 % of bill value of that day/that period except Sunda y & Paid Holiday.

- iii) No payment shall be made in case of strike /stoppage of work & penalty claim may not be applicable in that case.
- 7. a) Labour escalation: Labour escalation will be paid in this contract as per below formula.

Labour escalation:

The Labour wage escalation will be paid taking labour component @70% as per formula mentioned below up to the scheduled completion date including duly approved Time Extension, if any, on the items mention ed in the schedule of the items and rates. No escalation will be attracted for the period beyond duly approved time extension.

 $V = [70\% \times (L - Lo)/Lo] \times W$ , Where

V = Extra amount to be paid in Rupees

Lo = Rate of unskilled workmen as Chaibasa as on opening of tender

L = Rate of unskilled workmen as per ALC (C), Chaibasa for the period under consideration.

W = Total Value of work done in Rupees for the period under consideration

Note-

 E.P.F. Bonus, Labour Insurance, Labour licence(as required), Paid Holiday and safety equip ments are to be provided by the contractor at their own cost and should be included in quoted price.

Also leave with wages as per mines Act 1961 will be paid by the contractor at their own cost.

7. b) Reimbursement cost- for Safety equipment and tools & tackles will be done as per below-

(Safety shoes- Rs. 500 /-, Safety helmet- Rs. 300/-, Mask - Rs. 50 /- and jacket - Rs. 250/-). Cost of the same may be reimbursed <u>@every six month per manpower</u> by producing of Original Invoice with RA Bill.

#### 8. Geographical Presence :-

Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits of district of East Singhbhum /West Singhbhum & Seraikela Khars awan of state of Jharkhand where the services need to be provided. Documentary evidence must be provided in the form of trade license or other such documents as per the following which satisfies as a proof of h aving the office establishment.

- i. Trade License issued by the local authority in the name of the Firm or
- ii. Electricity bill for last one year in the name of the Firm or
- iii. Certificate of Registration or
- iv. GSTIN registration, EPF registration, ESI registration or
- v. Udyam/MSME/Udyog Aadhaar Certificate.
