- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 6. Past Experience of Similar Services: The Bidder must have successfully executed / completed at least one single order of 80 % of the Estimated Bid Value or 2 orders each of 50 % of the Estimated Bid Value or 3 orders each of 40 % of the Estimated Bid Value for similar service(s) in last three years to any Central / State Govt Organization / PSU / Public Listed Company. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The Tenderer who wish to participate in the Tender needs to fulfil the following Qualifying Criteria.

- 1. Experience of having successfully completed similar works during last 7 years ending last day of m onth previous to the one in which tenders should be either of the following

JOB DESCRIPTION

UCIL is interested to invite tenders for Rewinding and overhauling of 250K W and 280KW ,6.6KV, 3 phase squirrel cage induction motor. The party should h ave pool of experienced supervisors and technicians.

Scope of Work:

Loading and Unloading of motor and transportation of motor from UCIL site to C ontractor Workshop and after finishing the work, transportation of motor from t heir workshop to UCIL are in the scope of the contractor. All necessary arrange ments for shifting. Loading, Unloading to their workshop from UCIL site and to b ring back after rewinding are in the scope of the contractor.

- 1. Dismantling of motor and separating of stator and rotor
- 2. Cleaning of stator and rotor.
- 3. Removing old copper from stator slots. Cleaning of stator core.
- 4. Testing of stator for flux loop test
- 5. Completing rewinding of stator with class F Insulation in existing stator core p ack using enamelled fibreglass covered copper, impregnation (NON VPI), curing and finishing. Change of damaged circlips and essential things which are required for proper assembling and running of the motor are in the scope of the contractor.
- 6. Making of coils with DGFCEC copper as per old dimensions. Taping of coils with SEMICA THERM tapes. Taping of overhang portion with PGMP tapes.
- 7. Inserting of new coils. Making of end connections.
- 8. Checking of healthiness of rotor, stator, shaft etc and of any repair needs to be done, it is in the scope of the contractor. Dynamic balancing of rotor. Change rotor bearings. Supply of new bearings is also in the scope of UCIL. Change of rotor bearings is in the scope of the contractor.
- 9. Checking of all core laminations by hot spot test.
- 10. Preheating of the windings upto the required IR value
- 11. Applying varnish and becktol red to the windings
- 12. Checking of IR value of the winding. Changing of motor bearings.
- 13. Assembling of the motor with existing components and if any damaged circl ips are to be replaced with your own cost.
- 14. Testing of the motor and test certificate to be provided with warranty of 12 months.

Tests to be Conducted:

- 1. IR values of the windings
- 2. Resistance of the windings
- 3. UT test for shaft with certificate for detecting flaws

Trial run of the motor to be taken in plant (UCIL) after completion of rewin ding and overhauling and bearing replacement. Payment certification will be done after successful trial run at site. The contractor has to make his o wn arrangements during the trial run period.

AGREED LIQUIDATED DAMAGE:

Time shall be the essence of the contract. If successful Tenderer fails to execute the order within the greed stipulated schedule, he shall be liable to pay agreed liquidated damages a sum @ $\frac{1}{2}$ % of the c er value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 w ks, UCIL reserves the right to cancel the order and get the balance work/procurement done through a other agency at your risk and cost.

PERFORMANCE BANK GUARANTEE/DEFECT LIABILITY PERIOD/ SECURITY DEPOSIT

Defect liability period for the rewound motor shall be twelve months from the date of handing over motor after successful no load trial. In case of defects if any, the defects shall be rectified at free of c t basis within one month of information of the defect. In case of delay in attending the defect as stipuled above, the defect liability period shall get automatically extended. This should be backed up by a nk guarantee/SECURITY DEPOSIT for 3% of the contract value valid for defect liability period as per proforma.

PAYMENT TERMS:

Contractor shall be paid as per the following schedule duly certified by the Engineer-in-charge of the ntractor bill:

Payment shall be made within 30 days after submission of all documents related to bills and c ertification from Engineer In Charge

PERIOD OF CONTRACT: The contract period shall remain valid for a span of 4 months from the date of order issued in GeM. Site mobilization shall have to be done within 20 days on receipt of LOI/WO indicating contract price of the work. However, date of actual start of work shall be fixed by UCIL as per the site prevailing conditions.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
