- 1. **Scope of work:** Scope of work involves supply of 03 Nos. Skilled Electrician.
- 2. Bidder has to provide Three Electrician on daily basis i.e. One Electrician per S hift (A, B & C Shift) as per schedule of deployment and as instructed by Engine er In Charge throughout one year.

Shift Timings are as follows:

'A' Shift = 07:00 AM to 03:00 PM

'B' Shift = 03:00 PM to 11:00PM

'C' Shift = 11:00 PM to 07:00 AM

3. <u>Site Location</u>: Job site i.e. Narwapahar Mine which is situated at Narwapahar Mine in Dist: East Singhhum, Jharkhand at a distance about 16KM from Tatanag ar Railway Station.

4. Supervision:

The Engineer shall have the overall responsibility for co-ordination of contractor's work and his direction shall be final.

Such direction and supervision however shall not relieve the contractor of his re sponsibility of correctness and quality of workmanship and of other obligation under the contract.

5. **Safety measures:**

DETAILED SCOPE OF WORK

Special Terms & Conditions

- The Tenderers are advised to visit the site to acquaint themselves as to the nature and location of the work, the general and local conditions particular ly those bearing upon transportation, physical condition of the site, conditions of the ground, quality and quantity of surface to be encountered, the character of equipment and facilities needed preliminary to and during the progress of the work, and all other matters which can be of, in any way a ffect the work the cost thereof under the contract. Tenderer must have qualified persons with full knowledge and experience to carry out these jobs.
- The tenderer has to supply **03 Nos. Skilled Electrician** having ITI certific ate from recognized Institution. Each electrician must have working experie nce of minimum 02 years in maintenance / installation of LT Distribution pan el, Motor Starter Panel, Lighting Circuit and 11KV / 6.6KV Sub-stations. Document such as **ITI Certificate and working experience of minimum 02 y ears has to be submitted before commencement of work**.
- 3) Contractor has to provide detail address of their employees / workers enga ged for this work.
- The contractor shall ensure that the Manpower made available at shift thro ughout the period of contract (i.e) 12 months excluding Sunday as per following schedule:

- 5) <u>Contract Period</u>: One year (12 Months) from the date of issue of Work Order.
- 6) Income Tax & other taxes will be deducted as per norms of the Corporatio

- n, if applicable.
- 7) **INSURANCE:** The Labour Insurance will be covered as per rules and the in surance coverage for number of persons engaged for the work shall be for the whole period of contract and is to be submitted to corporation before commencement of the work. The contractor should also ensure the adequate number of workmen is provided for this work.
- 8) Contractors shall strictly abide by the security rules and regulations enforc ed by the owner from time to time. The contractor shall provide proper identity cards, badges etc to his employees wherever directed by the Engineer-in-charge or his representative.
- 9) All the payments to the contract employee like wage, PF, bonus etc should be done through bank payment only.
- 10) **GST:** The rates quoted shall be inclusive of GST.
- 11) **Bonus:** Contractor shall have to pay bonus to his employees as per rules.
- 12) **Provident Fund:** PF has to be deposited in employees PF account by the contractor as per rules. Proof of depositing PF has to be submitted along wit h the bill.
- 13) Contractor has to make online payment **Strictly as per the Minimum W ages Act** to his employees before 6th of every month irrespective of clearan ce of bill from UCIL. Proof of making payment has to be produced along with the monthly bills submitted by the contractor.
 - If the successful contractor fails to make payment to their employees before 6th of every month, UCIL as responsible principal employer will pay minimu m wages and provident fund as advance to contractual personnel and recovery of the payment shall be made from the contractor. In case of being similar instance second time, short closing of contract will happen and black listing procedure against the contractor shall be initiated.
- 14) **PAYMENT TERMS**: 11 (Eleven) Running Bill and 01 (One) Final bill is allo wed. Contractor shall raise bill once in a month on completion of one month contract period and submit bill along with necessary documents as a proof of payment made towards Min. wages + EPF + ESI + Bonus + GST. **Mandato ry: All the payments to the contract employee must be done through Bank Transaction only.**
- 15) MEDICAL CARE: The contractor shall be fully responsible for first aid and emergency medical treatment to his employees. Necessary arrangement for this purpose shall be made by the contractor at the site. Necessary medical test of his employees should be done by the contractor at his own cost. The test certificates have to be certified by UCIL Narwapahar CMO or his represe ntative. The tests have to be done as per norms of UCIL.

- 16) The Contractor must comply the training and IME (Initial Medical Examinati on) of skilled manpower to be conducted by GVTC, Narwapahar. The compli ance shall be submitted to corporation without which the contractor will not be allowed to work.
- 17) **TRAINING:** UCIL will impart training regarding to maintenance / fault r ectification technique of Drill Jumbo, Gate End Box, Mining type MCCB and o ther critical installations in underground mines for the period of 15 days on t he surface as well as in Underground. This period of 15 days shall be inclusive of training imparted by GVTC and IME by UCIL Hospital. After comp letion of training & medical of contractual manpower, they shall be deployed in U/G Mines in shift duties.
- 18) Labour Escalation (Revised Labour Rate) will be given as per notificati on of UCIL from time to time. Labour escalation will be paid as per formula mentioned below:

WEV = R X (W1-W0) X 0.80 / W0

WEV = Wage Escalation Value

R = Original Awarded Value/ Work Done Value

W0 = Minimum Labour wages based on Govt Notification as on the last date of submission of price bid or revised Price bid whichever is later.

W1 = Revised Minimum labour wages based on Govt. Notification during the period of Execution of work.

ESCALATION WILL BE APPLICABLE

- 19) Contractor has to deploy manpower as per direction of Engineer-in-Charge or his representative. Manpower may also be called on rest days and on holi days.
- 20) During weekly rest days of deployed contractual personnel, Contractor sha II depute other service personnel to meet manpower requirements as specified in schedule of deployment mentioned in point no 6.
- 21) **Tools & Tackles:** Contractor has to provide all tools and tackles for working to all Electricians.
- 22) **Defect Liability Period**: Not Applicable.
- 23) The estimated value for this work is Rs. 11,80,573 /- (Rupees Elev en lakhs eighty thousand five hundred seventy three only) (Includin g GST@18%) for an execution period of 12 months and 26 days for Electrici ans (Skilled Category) excluding Sunday in a month on the basis of sched ule of deployment of manpower mentioned in Point No.: 4 of Special Ter ms and conditions. The profit has not been included in the estimated value. Hence the bidders are advised to consider profit margin while quoting their price bid.
- 24) The payment of the National Holiday (i.e 26th January, 15th August

, 2nd October) will be paid to the contractual worker by the contractor as per the minimum wages act and the same amount will be reimbursed to the contractor after submission of the bill.
