Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of mont h previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs. 11,27,950.00/-

Or

- b) Two similar completed works each costing not less than the amount equal to Rs.7,04,969.00/-
- c) Three similar completed works each costing not less than the amount equal to Rs.5,63,975.00/-

"Similar work" means experience in Maintenance Contract for Floor cleaning work OR Machine cleaning works OR House Keeping work of Building Maintenance. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. - iv) GSTIN should be registered with the State of Jharkhand Only.
- v) MSME should be registered with JHARKHAND only within the range of EAST Singhbhum, West Singhbhum, Saraikela and Khareswa Districts.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
