Only such firms need tender who c an produce satisfactory evidence that they have the necessary experience & financial resources and organ ization to undertake such work as per criteria mentioned below.

- i) The Tenderer"s average annual turnover for the work during last 03 years, ending 31st March of the pre vious financial year, should be at least 30% of estimated value i e. Rs. 2.29 Lakhs in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer
- ii) Experience of having successfully completed for "Drilling of Bore Hole" during last 07 years ending last d ay of month previous to the one in which application are invited should be either of the following:

One single similar completed job costing not less than 80% of estimated value i e. Rs. 6.12 Lakhs. or

Two similar completed jobs costing not less than 50% of estimated value each i. e. Rs 3.82 Lakhs or
