Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. - 2. Experience of having successfully completed "**Similar works**" during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:
- a) Three Similar completed each works consisting not less than **40%** of estimated Cost or the amount equal to Rs **18.93** Lakhs or
