- i) The Tenderer"s average annual turnover for the work during last 03 years, ending 31st March of the pre vious financial year, should be at least 30% of estimated value i e. Rs. 11.30 Lakhs in Audited balance she et & profit & loss account of each year must be submitted by the tenderer
