PQC - 2 (Experience) (ii) The bidder should have experience of having completed similar work during the la st seven years ending the last day of month previous to one in which the applications are invited.

The bidder must attach completion certificate for each work.

a. Three similar completed work each costing not less than the amount equal to Rs. 56,750.40/-. or
