### 2. Forms of EMD and PBG

## PRE-QUALIFICATION CRITERIA (PQC) OF TENDERERS

Only such firms need to tender who can produce satisfactory evidence that they have the ne cessary experience & financial resources to undertake such work as per criteria mentioned b elow.

- i) Experience of having successfully completed similar work during last 07 years ending l ast day of month previous to the one in which applications are invited should be either of t he following:
  - a) One similar completed works costing not less than the amount equal to Rs.539260/-

Or

b) Two similar completed works each costing not less than the amount equal to Rs.33703 8/- c) Three similar completed works each costing not less than the amount equal to Rs.2696 30/-

"Similar work" means experience in maintenance or installation of 33KV overhead line or above. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate from the client and valid electrical contractor license issued by the state / central electricity licensing board as documentary evidence in support of their experience / credential failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.

- **ii)** Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such docume nts as per the following which satisfies as a proof of having the office establishment.
  - i. Trade License issued by the local authority in the name of the Firm OR
  - ii. Incorporation Certificate of the firm clearly mentioning office address OR
  - iii. Electricity bill for last one year in the name of the Firm OR
  - iv. GSTIN registration
  - v. Udyam/MSME/NSIC/SSI
- **ii)** The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financial year

i.e. 2022-23 should be at least **Rs.202223/-.** Annual Report containing Profit & Loss account and Balance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
