PRE-QUALIFICATION CRITERIA FOR THE TENDERERS

Only such firms need to tender who can produce satisfactory evidence that they have the necessary exper ience & financial resources to undertake such work as per criteria mentioned below.

1) Experience of having successfully completed similar work during last 07 years ending last day of month

previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs.7,19,101.60/-.

OR

b) Two similar completed works each costing not less than the amount equal to Rs.4,49,438.50/-.

OR

c) Three similar completed works each costing not less than the amount equal to Rs.3,59,550.80/-.

'Similar work' means the bidder shall be Authorized Service Provider of M/s Cummins India Limited and the bidder shall have experience of having successfully completed similar job of AMC of minimum 1010 kVA D. G. Set. The bidder will have to submit copy of the work order from the client and completion certificate / co py of agreement / LOI / LOA as documentary evidence in support of their experience / credential. The bidd er shall also submit valid documentary proof for being an Authorised Service Provider of M/s Cummins Indi a Limited.

2) The tenderer's average annual turnover during last 03 financial years, ending 31st March of the previou s financial year should be at least Rs.2,69,663.10/-.
