Only such firms need tender who can produce satisfactory evidence that they have the necessary experience & financial resources and organization to under take such work as per criteria mentioned below.

- The Tenderers average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least **30%** of estimated value i e. Rs. 4.45 Lakhs in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer
