- 1. The deployed manpower should be experienced and shall be capable to undertake the assigned job withou t requiring any post selection training.

The necessary documents regarding their qualifications and experience should be submitted along with acceptance letter of work order. Selection of Consultant: The experienced certificate and screening of personnel deputed for the said wo rk has to be carried out in consultation with the UCIL. The consultant will be deployed based on experience and selection by interview.

Before deployment the UCIL will take interview of individual consultant in presence of the contractor and s uitable candidates only will be selected based on their performance in the interview.

<u>Remuneration</u>: The monthly remuneration to be paid to the Consultant shall be **Rs. 65,000/-** [Rupees Si xty Five Thousand only] by the contractor as per the 'Comprehensive guidelines for engagement of retired Govt. Officials /Officials as consultant' dated 30/11/2018 issued by Ministry of Labour and Employment, Go vt of India vide OM no. F no.A-12034/11/2018-Admin.I (Annexure-1).

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
