- 1. - 2. Minimum average turnover of Rs. 03.08 Lakh i.e. 30 % of the estimated value of the work for last 3(three) financial years and submission of duly audited copy of Profit & Loss account and Balance sheet of financia I years 2020-21, 2021-2022 & 2022-23 by Chartered Accountant.
- 3. The Bidder shall submit registration copies of PAN, GST, MSME/NSIC, PF, ESIC and Income Tax Return St atement.
- 4. Similar Works means-"Any Civil Work / Garbage Disposal work" with Govt. / PSU / Public Limited Organiz ation / Private Limited Organization."
- 5. Relaxation of conditions of prior turnover and prior experience: Pre-qualification criteria with respect to Prior Turnover and Prior experience may relax all MSE's and Start-ups as per GOI guidelines subject to mee ting of Quality and Technical specifications. UCIL may consider allowing the participation of ''MSE's and Start up'' companies with capability to execute the supply/ services, as per technical specifications/ perform t

he job as per scope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of India. This should be confirmed and substantiated in the technical bid. The bidder who inte nds to participate as "Start-up" company should enclose the Certificate of Recognition issued by Departme nt of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during submission of Technical bid. Note – The bidders see king relaxation for prior experience and turnover must enclose the certificate over the relevant criteria as mentioned in the bid, otherwise the bidder will not be considered for exemption.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM.
