Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

2. NABL Accreditation Certificate, ISTN/ASTN certificate for person conducting tests and other information.

a) The agency shall be a Govt. Scientific Research Institute or shall have valid certificate of Accreditation in accordance with the standard ISO/IEC 17025:2005 in the specific discipline of the applicable Non-Destructive Testing methods and vibration analysis from National Accreditation Board for testing and calibration laboratories. (NABL)

b) The bidders have to submit valid NABL certification of accreditation for carrying out NDT tests in the field

d of testing with scope of accreditation as per testing standard sheet of NIT documents.

c) The Bidder, at the bidder's own responsibility, cost and risk, is required to visit and examine the site of works and its surroundings, approach road, soil condition, investigation report, existing works, if any, connected to the work, drawings connected to the tendered work, if/as available and obtain all information that may be necessary for preparing the Bid and entering into a contract for execution of the works. The cost of visiting the site shall be at the bidder's own expense.

d) The manpower engaged by the contractor shall have skill in conducting various test mentioned in BOQ, All NDT shall be performed by ASNT level 2 qualified personnel with valid certification. The testing to be reviewed and report to be signed by an in-house ASNT level 3 person. Copies of all qualified personnel performing the test to be submitted.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
