- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Buyer Added Bid Specific Terms and Conditions

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all

statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

4. Forms of EMD and PBG

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

The invitation for bid is open to all bidders including an individual, proprietorship firm, partnership firm or a company having

eligibility to participate as per eligibility criteria stipulated in tender document. Joint Venture/ consortium are not allowed to

participate in the tender. Percentage (%) share of each eligibility criteria (100% in case of an Individual/ proprietorship firm or a

partner in a partnership firm). The following are the Eligibility criteria for this Non-divisible Works Contract.

1 PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

The bidder' having the minimum 3 years' experience of successfully execution (completion) of at least one (01) or

more numbers of similar type of contract of "hiring of commercial vehicles" to any Central / State Govt. Organization

/ PSU / Public Listed Company in last seven (07) years ending on last date of the previous month in which

issued.

i) The eligibility period shall be within the period of 7 years backwards starting from the last day of month previous to the

publication date of BID.

ii) The work experience of the bidder for those works only shall be considered for evaluation purpose, which is completed

before the last date of month previous to the one in which the BID has been published on GeM portal. Hence, the works

which are incomplete/ ongoing, as on the last date of the month previous to the one in which the BID has been published

on GeM Portal, shall not be considered against eligibility.

iii) In case the work is started prior to the eligibility period of 7 (seven) years (counted backwards starting from the last date of

the month previous to publication date of BID and completed within the said eligibility period of 7 years, then the year of

experience of the work within the said eligibility period shall be only considered against the eligibility.

DOCUMENTARY EVIDENCE IN SUPPORT OF PAST PERFORMANCE AND PROJECT/ PAST EXPERIENCE etc.

CRITERIA: - In support of the claim of meeting this experience/ technical criteria, bidder must submit following

documentary proof in GeM portal.

a. Copy of relevant work order/ Purchase order/ Service order clearly mentioning nature of work/ Service, various

components/ Items, period and value.

b. Copy of completion/ execution/ client certificate issued by end user/ owner clearly mentioning reference to relevant work

order / Purchase order/ Service order, actual value of executed work and actual date of completion.

c. FORM 16(A) has to be submitted in case of Public Listed Private Company.

2 FINANCIAL STANDING:

Average annual financial turnover during the last 3 (three) years, ending 31st March of the previous financial year should be

at least 30% of the estimated cost put to tender. (The "Previous financial year" shall be computed with respect to the

Publication date of BID).

- 1) The average shall be compared with the minimum requirement to ascertain the eligibility status of the bidder.
- 2) If any bidder does not submit the Turnover value for any of the 3 years, the bidder will not disqualify and instead shall

consider all 3 years for computing the average assuming a value of "zero" for the year for which no information has been

furnished by the bidder.

3 GEOGRAPHIC PRESENCE: Office registration certificate: Registered Office or at least one of the registered Branch Office of

the bidder shall be located and registered within the geographical limits of Jharkhand State where the services need to be

provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per

the following which satisfies as a proof of having the office establishment.

- i. Trade License issued by the local authority in the name of the Firm or
- ii. Landline phone number in the name of the Firm or
- iii. Electricity bill for last one year in the name of the Firm or
- iv. GSTIN registration or
- v. Udyam/MSME/Udyog Aadhaar Certificate.
- 4 EPF registration copy, GSTIN copy, PAN copy must be submitted along with the bid.

5 The bidder has to submit an undertaking to deploy the offered vehicles with all supporting documents within one

month from the date of issue of LOA/ work order on their letter head along with bid (scan copy uploaded in GeM).

6 Any bid not complying PQC requirements shall be summarily rejected.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity/restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and/or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents/clauses shall also be null and void. If any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations. Also, GeM does not permit collection of Tender fee / Auction fee in case of Bids / Forward Auction as the case may be. Any stipulation by the Buyer seeking payment of Tender Fee / Auction fee through ATC clauses would be treated as null and void.

This Bid is governed by the <u>General Terms and Conditions</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
