The eligible criteria to qualify in Techno commercial Part are as below:-

1. Bidder shall have successfully executed similar work during last 03 (three) years ending last day of month previous to the one in which tender is invited as per any one of following:
 - a) Three(3) similar completed work each costing not less than the amount equal to 40% (17.99 Lakhs) or
 - b) Two (2) similar completed works each costing not less than the amount equal to 50% (22.48 Lakhs) or
 - c) One (1) similar completed work costing not less than the amount equal to 80% (35.98 Lakhs).

Bidders must attach Work done certificate mentioned executed amount and date of completion also attached Work order with bill of quantities for related job completion certificate.

The bidder shall visit the proposed work site to well acquaint about the site work before filling the rate /submit the tender.

2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be at least 13.49 Lakhs. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution /

incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. **GEOGRAPHIC PRESENCE:** Office registration certificate: Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits i.e Jharkhand State. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

i).Trade License issued by the local authority in the name of the Firm or

2. **Generic**

OPTIONAL SITE VISIT:

1. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder. yes, cost of visiting the site shall be borne by Bidder.

2. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.
