1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Pre- qualification criteria (PQC):

1. **'The bidder' should have "renting and leasing of motor vehicles" Or "tour & travel nature of business" and should have its own operation office at within 50 km radius of the area of Jaduguda, Jharkhand and having a minimum Twelve (12) months of operational experience in similar type of contract of providing vehicles to any Central / State Govt. Organization / PSU / Public Listed Company during the period of last five (5) years ending on last day of month previous to one in which NIT was issued.** To support their experience criteria, bidder should submit copies of relevant Contracts or Work Order, along with evidence in respect of satisfactory execution of each of those contracts, in the form of copies, such as
 - a. Satisfactory completion/ performance report. In case work is continuing at the time of bidding, then bidder should submit satisfactory performance certificate from the existing client for executed work period & contract value **(or)** Proof of release of performance security after completion of the contract **(or)** Proof of settlement/ release of final payment against the contract **(or)**
 - b. If time period of two or more contracts are overlapping then common period will be considered as one period only.
 - c. FORM 16(A) has to be submitted in case of credential from the client of Public Listed Private Company.
2. **GEOGRAPHIC PRESENCE:** Office registration certificate: Registered Office or at least one of the registered Branch Office of the bidder shall be located and registered within the geographical limits within 50 km radius of the area of Jaduguda where the services need to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
 - i. Trade License issued by the local authority in the name of the Firm or
 - ii. Landline phone number in the name of the Firm or
 - iii. Electricity bill for last one year in the name of the Firm or
 - iv. GSTIN registration or
 - v. Udyam/MSME/Udyog Aadhaar Certificate.
3. **GSTIN copy, PAN copy must be submitted along with the bid.**
4. Any bid not complying PQC requirements shall be summarily rejected.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
