- 1. 1. Generic

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

4. Generic

The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

7. Generic

OPTIONAL SITE VISIT:

- 1. The Bidder is advised to visit and examine the installation site and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid. The costs of visiting the site shall be borne by the Bidder. YES
- 2. The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.
- 3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.

8. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

9. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

10. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

11. Payment

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

12. Past Project Experience

For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:

For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. 15. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

Scope of Work

JOB DESCRIPTION

UCIL has operating uranium ore processing plant at Turamdih, which is around 5KM from Tatanagar Railway Station towards Hata to meet the increasing demand of uranium. Presently it is running at 3000 TPD capacity and Commissioning activities of 1500TPD more capacity are near to completion.

C&I System of Turamdih Mill is based on Schneider make Premium series PLC. There are 4nos.of LPRs (Local Panel Rooms), 2nos. of Monitoring Rooms and one CCR (Central Control Room) for control and operation of complete plant. Apart from PLC System, various conventional instruments (like-pH, ORP, Flow, Temperature, Level, Turbidity, Density transmitter and switches) and non-conventional instruments (like-Particle Size Analyzer/ XRF Analyser, Portable Flow meters etc.) are provided in the plant for on-line monitoring and control of the process parameters from Control Rooms. C&I systems is backed up by strong communication system (Telephone, Radio System, Public Address System, CCTV System) to communicate with plant personnel.

EMENT:

As mentioned above, various types of Electronic equipments (Amplifier / Power Supply / Digital Panel Meter/ Auto Manual Station / UPS/ Monitor / Power Adaptor / TV sets /Load Indicator / SMPS /pH meter/ Inverter / Battery charger/ Telephone Sets / Temperature Indicator / CCTV Camera / DVR & NVR/ Signal Isolator etc provided for operation, monitoring and control of the plant from Central Control Room (CCR) / Local Panel Room (LPR).

Tenderer has to supply manpower for repairing, maintenance and up-keeping of electronics equipments installed in the Turamdih mill. The bidder should supply only those manpower which are capable to take-up the job assigned to them without need of any sort of training. Components required for the maintenance of the equipment shall be provided free of cost. A space shall be provided to the deputed person, It is their responsibility to keep the site clean and proper arrangement for the

Duties of Supplied Manpower:

- a. Removing of equipment from Plant, Cleaning, fault finding and component replacement, testing and fitting at site.
- b. Obey the decorum of the plant & office.

c. Job priorities shall be fixed by section-in-charge.

WORK FORCE:

Contractor has to provide workforce (Manpower) only for repair and upkeeping of electronics equipment. Tools, tackles and components shall be provided by UCIL as free supply.

The minimum desirable qualification and experience are given below:

Skilled Category: Should have ITI in Instrumentation / Electronics / Electrical discipline or class 12th with 3 years experience in the field of Electronics repairing.

Semi-Skilled Category: Should have 10th pass with 5 years experience in the field of Electronics repairing.

Trade test of work force will be taken by a team of UCIL and workforce will be approved after satisfactory performance.

Resource Deployment:

Maintenance services will be required on General Shift duty. However during emergent situation they may be called to work in round the clock shift basis.

16. Buyer Added Bid Specific ATC

Addition Terms & Condition.

- 1. EMD: NIL/-
- 2. Security Deposit: 3% of the ordered value. Mode of submission of Security Deposit by successful bidder shall be as mentioned in Bid Document.
- 3. Documents accompanying the Bid document: Following documents must be uploaded during bid submission.

- 6. **Payment of wages:** Payment of wages to the workmen deployed under this contract shall be paid by Bank cheque/ E-transfer of funds. Documentary evidence shall be enclosed along the RA bills.
- 7. Reimbursement for variation in Taxes / Imposition of new taxes: The Contractor will be paid at actual against production of documentary evidence for any variation in statutory taxes, duties etc. or any imposition of new Governmental taxes /duties during the Contract execution period. For this purpose, the bidder should indicate clearly in his price bid the details of taxes and duties considered for all those major items for which he intends to claim for such reimbursement.
- 8. SHIFT SCHEDULE: Normally the manpower will be called to work in General Shift of UCIL (7AM

to 5PM, Lunch break 12 Noon to 2 PM). However incase of emergent situation, they may be call in round the shift (A, B or C shift duty).

17. Buyer Added Bid Specific SLA

Text Clause(s)

Specific SLA clauses

- 1. **Wages meaning:** In this contract Wages mean Minimum wages (Basic + VDA), EPF, ESIC, Bonus. Rate of EPF, ESIC and Bonus is as per government notification.
- 2. **Contract Agreement**: The contractor has to undergo contract agreement with purchaser on a non-judicial stamp paper of Rs. 20/- (2 Nos.each) along with 6 nos. of judicial dummy paper. The contractor has to submit security deposit prior to execution of contract agreement.
- 3. Penalty: Penalty due to absentism shall be imposed as below:

- 6. **PERIOD OF CONTRACT:** The period of Contract is one years **(312 working days incl. 3 paid holiday)** from the date of issue of work order / commencement of work.
- 7. **FAIR WAGES:** The wage paid to the workmen shall not be less than fair/minimum wages fixed by the central government (Chief labour commissioner) from time to time. The tenderer is deemed to have taken this aspect in his unit rates estimation for various items of work covered under this contract.
- 8. **PAYMENT:** The contractor shall submit the monthly bill in triplicate to UCIL for payment of the completed work. The contractor shall submit his bills immediately after completion of the month. UCIL will make payment to contractor within 30 days from the date of submission of bill.
- 9. **Documents accompanying the Bill:** Following documents (in triplicate) shall be submitted along the bill:
 - a. Invoice
 - b. Certified Attendance sheet.
 - c. Copy of wage register
 - d. Salary slip.
 - e. Salary reimbursement of deployed manpower (Bank Transfer & Account statement)
 - f. PF Statement along with paid challan and remittance copy.
 - g. ESIC Statement, challan and remittance copy.
- 10. All other terms & Conditions: As per Gem SLA.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Any clause incorporated by the Buyer such as demanding Tender Sample, incorporating any clause against the MSME policy and Preference to make in India Policy, mandating any Brand names or Foreign Certification, changing the default time period for Acceptance of material or payment timeline governed by OM of Department of Expenditure shall be null and void and would not be considered part of bid. Further any reference of conditions published on any external site or reference to external documents / clauses shall also be null and void. If any seller has any objection / grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions</u>, conditons stipulated in Bid and <u>Service Level</u>
<u>Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
