Our Pharmacy Department is outsourced and presently we are getting uniform discount @ 23.10% of MRP on all medicines.

We are also having local medicines supplier for supply of those medicines which are not provided by outsourced pharmacy. Presently we are getting uniform discount @ 22% of MRP on all medicines from local medicine suppliers as per list enclosed.

Expression of Interest who wish to offer higher discount are invited from authorised drug distributor / retailer having their retail outlet under Jamshedpur Notified Area, Mango Notified Area, Jugsalai Notified Area and Adityapur Notified Area in prescribed Form, Annexure-A.

ANNEXURE-B

1. **Scope of Works: -**

(a) Medicines prescribed by the UCIL'S doctors (JADUGUDA /NARWAPAHAR/TURAMDIH) should only be supplied and medicines with similar combination will not be accepted without doctor's advice in writing.

(b) The supplier shall bring the medicines on all working days to authorized representative of UCIL. After receipt at UCIL the medicine will be verified and distributed by our pharmacist.

(c) Medicines of every green slip issued by UCIL'S doctors (JADUGUDA /NARWAPAHAR/TURAMDIH) will be packed separately in a paper bag mentioning Name and Employee no of the Patient and hand over to our authorized representative of UCIL.

(d) Subsequently Receipt of the above medicine will be given by our pharmacist after verification at our end. In case of any discrepancies same will be sorted out by the supplier on their own cost.

2. **SPLITTING OF CONTRACT:** To ensure smooth supply, effort will be made to split the contract H1 (Highest discount) & H2 (Second Highest discount) quoted Bidders subject to matching of H1 bidder's discount by the H2 bidder. However, incase H2 bidder does not match the H1 bidder's discount then same opportunity will be given to H3 bidder to supply the Medicines at H1 bidder's discount and so on, if none of the bidders agree to match H1bidder's discount then complete contract for supply of Medicines will be awarded on H1 bidder only. In case of tie or under other inconclusive situations then UCIL's decision towards award of contract will be final and binding upon participated bidders.

3. **Basis of Evaluation Clause:** Contract will be awarded on the successful qualified bidders based on highest single composite discount offered by them as per Annexure-A and considering splitting of contract clause.

4. Bidder should quote single composite discount as per Annexure-A failing which their offer is liable to be rejected and their given discount may not be considered for evaluation process. For supply of medicines after bifurcation of Tax part from MRP, discount offered as per price format (Annexure-A) shall be applicable. Subsequent to this GST extra as applicable shall be paid on discounted price.

5. Single Composite discount offer by the bidder will be valid for supply period of one year from the date of contract. However contract period may be extended further on same terms and conditions and discount subject to satisfactory performance and mutual consent.

6. **Period of Contract:** The contract will be given initially for the period one year. However contract period may be extended further on same terms and conditions and discount subject to satisfactory performance and mutual consent

7. **Value of Contract:** Value of contract depends upon non-supply of medicines by our outsourced pharmacy..

8. **Delivery Schedule: -** Medicines should be delivered to UCIL'S authorised representative at respective hospital within one day from the date of receipt of green slip. In case of short supply as per green slip supplier should intimate in writing to concerned CMO of UCIL

(JADUGUDA /NARWAPAHAR/TURAMDIH) and subsequently arrange to supply the short medicine within 02 days to UCIL Hospital on their own cost.

9. **Payment Terms:** Payment will be made within 30days from the date of receipt of composite statement on a weekly basis from the supplier. However supplier should submit bill against each green slip issued by UCIL Doctors on day to day basis.
10. **Price Terms:** FOR destination on door delivery basis at respective UCIL'S Hospital JADUGUDA, NARWAPAHAR, TURAMDIH.
11. **Cancellation of Contract:** It will be your endeavour to execute the contract to our satisfaction. In case of your failure to do so, the contract is liable to be cancelled.
12. **Acceptance of Tender:** The final acceptance of the tender rests with UCIL, who reserves to itself the right to reject any or all tenders without assigning any reason.
13. **Bidder should submit their offer as per our enclosed price format (Annexure-A)** failing which their offer is liable to be rejected. Conditional offer of the supplier will not be acceptable and their quoted discount will not be considered for evaluation purpose after opening of offer.
14. **Bidder should indicate in their offer that all terms & conditions of our enquiry is acceptable to them in totality failing which their offer is liable to be rejected.**
15. **RELATED PARTY CLAUSE :** Subsequent to tender opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
16. **FORCE MAJEURE:** Force majeure is an event beyond the control of supplier/contractor and not involving the suppliers/contractor's fault or negligence and which is not foreseeable. Such events may include, but are not restricted to acts of the purchaser/contractor either in its sovereign or contractual capacity, wars or revolution, hostility, acts of public enemy, civil commotion, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts and freight embargoes or any other event which UCIL may deem fit to consider so. The decision about force majeure shall rest with UCIL which shall be final and binding. Force Majeure clause has to be compulsorily embedded in the order. If there is delay in performance or other failures by the supplier/contractor to perform obligations under its contract due to event of a Force Majeure, the supplier/contractor shall not be held responsible for such delays/failures
If a Force Majeure situation arises, the supplier/contractor shall promptly notify the purchaser in writing of such conditions and the cause thereof within fifteen days of occurrence of such event. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as reasonable/practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event

If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of Force Majeure for a period of exceeding sixty days, UCIL may at its option terminate the contract without any financial repercussion on either side.
17. **ARBITRATION:** Notwithstanding anything contained in this Contract, all question, disputes or differences whatsoever which is not amicably settled as mentioned in Dispute Resolution clause, between the parties to the contract, arising out of or relating to the work as per provisions of the contract or matters related thereto whether during the period of the contract or its failure or after the completion of the contract, shall be decided by Arbitration under the provision of the Arbitration and Conciliation Act, 1996 as amended from time to time.
Parties shall endeavour to appoint an Arbitrator from a panel of Arbitrators, the names of which shall be provided by both parties. In the event of failure of appointment of an arbitrator by the parties, the provisions contained in Section 11 of Arbitration & Conciliation Act,1996 as amended from to time shall apply.
18. **JURISDICTION:** The Civil court of competent jurisdiction within the district shall have jurisdiction.
