If none of the bidders agreed to match L1 bidder's rate then order for 100% quantity will be awarded on L1 bidder. Opportunity of price match request will be given to a ll the parties on single time as per GEM.

However MSE/MII and GeM splitting rule shall prevail over the said splitting cla use and subsequent to price bid opening and during the time of splitting of ord er quantity, options allowed by GEM portal for splitting of quantity shall be appl

- icable and binding to the participated bidders.
- 6. Party shall be decided as L1 on Composite cost of Booster explosive and Column explosive.
- 7. Guarantee/Warranty: Guarantee/ Warranty for explosive shall be three (03) m onths from the date of its supply.
