- 1. ## 10. Generic

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

2. PRO RATA PENALTY: In case life obtained of the tyre is lower than 400 hours of operation ,then Pro-rata penalty amount will be deducted on pro-rata basis. Pro-rata penalty amount will be calculated on proportio nate basis as per formula given below:

A = Original Tread Depth of the tyre

B = Remaining Tread Depth at the time of failure of tyre

C = Cost of the tyre

Life of the tyres will be monitored and reports of life of tyre will be jointly prepared and sig ned on monthly basis by both incharge of UCIL Mines and supplier's representative. This re port will be the basis for penalty deduction, if any.

- 3. Related party clause: Subsequent to bid opening, if it is found that bids submitted by related parties in wh ich there seems to be collusion are liable to be rejected. Parties are considered to be related if one party h as ability to control the other party or exercise significant influence over the other party in making financia I and / or operating decision.
