- 1. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. 10. Generic

- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

1) Dispute resolution Mechanism and Jurisdiction:

- a) **Conciliation**: Notwithstanding anything contained in this contract, any disput es or differences whatsoever, which are to be settled amicably between the parties with their authorized representative, shall be resolved through conciliation.
- b) **Mediation**: Any disputes or differences, which are not settled amicably throu gh conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- AMRCD: Any disputes or differences between the parties are not settled amic ably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enter prises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d) **ARBITRATION**: Any disputes or differences where clause no. (c) is not

applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr . (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitrati on shall not be a method of dispute resolution arising out of this contract.

- e) **Jurisdiction**: If the matter is not resolved through above means, the dispute s hall be resolved in civil court of law at Jharkhand only.
- 2) Similar Category has been defined for Techno-Commercial evaluation of PQC Similar category are items which are used for carpentry or formwork or shutting work.
- **3)** Transit permit if required shall be provided by bidder.
- **4)** Guarantee/Warranty: Guarantee/ warranty shall be for a period of 12 months from the date of receipt and acceptance of material at our stores.
