Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

I. PRE-QUALIFICATION CRITERIA (POC)/ ELIGIBILITY CRITERIA

The followings are the Eligibility criteria for this Non-divisible service Contract. The bidder may visit the proposed work site to get well acquainted about the site work before filling the rate/submit the tender.

1. PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

Bidder shall have successfully completed similar works during last 7 (Seven) years ending on bid opening date as per any one of following:

1. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to 40% of the estimated cost **(75.00 Lakh)**

OR

Two similar completed works costing not less than the amount equal to 50% of the estimated cost **(93.75 Lakh)**

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost **(1.50 Crore)**

The "Similar Work" means "**Experience in execution of "Transportation work of Minerals / Tailings/ Sand/ Aggregates/ Fly Ash/ Other Minerals".**"

(Work Order Copy & Completion Certificate / Invoice copy should be attached as supporting document)

2. **FINANCIAL STANDING:**

Average annual financial turnover during the last three financial years should be at least 30% of the yearly estimated Cost **(56.25 Lakhs)**.

3. **GEOGRAPHIC PRESENCE:**

Office registration certificate: Registered Office within the geographical limits of **Jharkhand state** where the services need to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- I. Trade License issued by the local authority in the name of the Firm or
- II. Local Employee Exchange registration for contractor as per Govt. of Jharkhand. Or
- III. GSTIN registration or
- IV. Udyam Certificate.

Without submission of the above documents for Office address in the State of Jharkhand, then the Bidder will be disqualified in Techno Commercial bid.

4. EPF registration copy, ESIC, GSTIN copy & Make in India Compliance must be submitted along with the bid.
5. Any bid not complying PQC requirements shall be summarily rejected.
6. EMD exemption only to relevant MSME/MSE.
7. Prior Turnover exemption for relevant Startups as per government guidelines.
8. The tender documents shall be issued free of cost to company/units registered with MSME/National Small Industries Corporation/Director of Industries of State, Cottage Industries approved by the State Authority or any other entity as may be specified by Govt. guidelines from time to time, after ensuring that the approval pertains to the class of item/works for which tender is floated.

NOTE:

If the works are provided by the contractor in accordance with this contract, Corporation will pay to the contractor the price (awarded value); and reimburse the contractor for the approved expenses (as specified in the order/ contract), after the approved expenses have been incurred by the contractor. Corporation will not be liable to reimburse the contractor for expenses other than approved expenses, unless Corporation's prior approved written consent.

II. Scope of work: The scope of this tender will be generally as per specification schedule of quantities and general / special conditions of contract and as directed by Engineer in charge, on behalf of Corporation. However, the scope of work covered complete in all respect under this contract are as follows:

1. Loading of Uranium ore by mechanical means like wheel Loader from UCIL, Bagjata Mines and transportation of the same up to Mill of UCIL, Jaduguda in covered and well maintained Tippers/Dumper and dumping the same at ground hopper of UCIL Mill, Jaduguda including weighment at Jaduguda weigh bridge as per directions of Engineer-in-charge.

2. Loading of Mill Tailing by mechanical means such as wheel loader/JCB Loader from UCIL Jaduguda tailing paddock, weighment of tailings to be done at Jaduguda weighbridge and transportation of the same up to UCIL, Bagjata Stowing yard in covered and well maintained Tippers/Dumpers, inclusive of all handling, tools etc. complete, as per directions of Engineer-in-charge.

3. Bagjata Mines is located 32 km East of Jaduguda Mines and 11 km East of Mosaboni Mines in the Singhbhum East district of Jharkhand State.

4. For quality check of ROM, all Tippers carrying ore have to pass through the BOA (Bulk Ore Analyzer)/ARCH Room before it is being dispatched to Jaduguda.

5. Schedule of work mentioned in BOQ to be carried out as per direction of Engineer-in-charge.

6. The heavy vehicles required for the work on hire basis should not be manufactured earlier than the year 2016.

7. Spillage etc during transportation of ore and tailing – While transporting, all loaded dumpers/Hyva etc must be covered with Tarpaulin as per following specification.

(a) Tarpaulin made of canvas/high-density polyethine cloth stitched and having eyelets fitted on all borders. The size of the tarpaulin shall be larger than the dump box so as to cover the top of the dump box completely.

(b) The tarpaulin is to be fixed on all side hooks of the dumper in such a way that at least it will be 200mm below from the rim of the dump box.

(c) Tarpaulin must be changed as and when insisted by the Engineer in charge, to avoid the dust and spillage in the public surrounding area/villages/on road.

8. Dumping of ore and tailing outside the company area:

If dumping of ore or tailing becomes unavoidable due to repair and maintenance or any other reasons like overturning or any other accidental causes the Bidder shall clear the dumped ore or tailing within 48 hours of such incident and failing to do so, the UCIL shall take steps to clear the ore or tailing and the cost incurred shall be deducted from the running bill of the Bidder. The cost involved to clear the ore or tailing shall be intimated to the Bidder within 48 hours before carrying out the work and if Bidder does not reply immediately after getting the intimation it will be deemed that Bidder has no objection to the estimated cost.

9. PPE's i.e. Safety Shoe, Uniform, Safety Jacket, Nose mask, Ear plug, Safety goggles, Safety helmet to be provided by the contractor.

Note:-Contractors are advised to see the area get acquainted with the actual features of the land where work is to be executed and get other related information before quoting their rates for carrying out the work successfully.

Scope of Bidder:

- 1) The contractor shall deploy minimum of Four Dumpers everyday to achieve the Ore Transportation target per day. Weekly rest and leave will be applicable as per respective act.
- 2) The Bidder shall provide 3 national Holidays for all workmen.
- 3) Tailings should be brought from Jaduguda Mill as and when desired or instructed by EIC.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
