Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Average Annual financial turnover during the last 3 (Three) consecutive financial years, ending 31/03/2025 shall be at least 30% (12.34 Lakhs) of the estimated cost supported by audited annual accounts. Turnover certificate must contain unique document identification number (**UDIN**), Turnover document submitted without UDIN shall be summarily rejected.
2. Bidder shall have successfully completed similar works during last 07 (Seven) years ending on last day of month previous to the one in which applications are invited should be either of the following:
 - a. Three (3) similar completed works each costing not less than the amount equal to 40% (16.45 Lakhs) of the estimated cost
 - or
 - b. Two (2) similar completed works each costing not less than the amount equal to 50% (20.57 Lakhs) of the estimated cost
 - or
 - c. One (1) similar completed works costing not less than the amount equal to 80% (32.91 Lakhs) of the estimated cost.
3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.
4. Party should be MII class I local Supplier. The Minimum local content to qualify as a class-I local supplier is denoted in the bid documents. All bidders must upload all certificates regarding the Percentage of the local content along with the place of value addition, in their bid, failing which the bid is liable to be rejected.
5. Similar works means Experience in execution of work with any Central /State Govt.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**
