OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

JOB DESCRIPTION

UCIL is interested to invite tenders for Rewinding, overhauling and bearing replacement of 2 No's of 250KW 6.6KV, 3 phase squirrel cage induction motor. The party should have pool of experienced supervisors and technicians.

6.00.00 Scope of Work:

Loading and Unloading of motor and transportation of 250KW motor from UCIL site to Contractor Workshop and after finishing the work, transportation of 250KW, 6.6KV, motor from their workshop to UCIL are in the scope of the contractor. All necessary arrangements for shifting, loading, Unloading to their workshop from UCIL site and to bring back after rewinding are in the scope of the contractor.

1. Dismantling of motor and separating of stator and rotor
2. Cleaning of stator and rotor.
3. Removing old copper from stator slots. Cleaning of stator core.
4. Testing of stator for flux loop test
5. Completing rewinding of stator with class F Insulation in existing stator core pack using enamelled fibreglass covered copper, impregnation (NON VPI), curing and finishing. Change of damaged circlips and essential things which are required for proper assembling and running of the motor are in the scope of the contractor.
6. Making of coils with DGFCEC copper as per old dimensions. Taping of coils with SEMICA THERM tapes. Taping of overhang portion with PGMP tapes.
7. Inserting of new coils. Making of end connections.
8. Checking of healthiness of rotor, stator, shaft etc. Dynamic balancing of rotor. Change rotor bearings. Supply of new bearings is in the scope of contractor. Change of rotor bearings is in the scope of the contractor.
9. Repairing/ Machining/ replacement of damaged NDE side outside and inside bearing cups if necessary. No additional cost will be given for this scope. The contractor has to quote considering the total scope of work while quoting.
10. Checking of all core laminations by hot spot test.
11. Preheating of the windings upto the required IR value
12. Applying varnish and bectol red to the windings
13. Checking of IR value of the winding. Changing of motor bearings.
14. Assembling of the motor with existing components and if any damaged circlips are to be replaced with your own cost.
15. Testing of the motor and test certificate to be provided with warranty of 12 months.
16. Supply and replacement of space heaters in motors is in the scope of the contractor. The contractor has to check the existing space heaters available in motor and if needed replace it with new if damaged /not available.
16. Checking and Testing of RTD's is in the scope of contractor and a report to be submitted related to RTD's and space heaters of the motors.

6.01.00 Tests to be Conducted:

1. IR values of the windings
2. Resistance of the windings
3. UT test for shaft with certificate for detecting flaws

Trial run of the motor to be taken in plant (UCIL) after completion of rewinding and overhauling and bearing replacement. Payment certification will be done after successful trial run at site. The contractor has to make his own arrangements during the trial run period.

(6) BANK GUARANTEE:

Wherever stipulated should be as per our proforma issued by an Indian Public Sector Bank. All bank charges to be borne by bidder. Bank Guarantee should be automatically extended for validity period in the event of delay in execution of contract.

(7) AGREED LIQUIDATED DAMAGE:

Time shall be the essence of the contract. If successful Tenderer fails to execute the order within the agreed stipulated schedule, he shall be liable to pay agreed liquidated damages a sum @ ½ % of the contract value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 weeks, UCIL reserves the right to cancel the order and get the balance work/procurement done through another agency at your risk and cost.

(8) PERFORMANCE BANK GUARANTEE/DEFECT LIABILITY PERIOD/ SECURITY DEPOSIT

Defect liability period for the rewind motor shall be twelve months from the date of handing over motor after successful no load trial. In case of defects if any, the defects shall be rectified at free of cost basis within one month of information of the defect. In case of delay in attending the defect as stipulated above, the defect liability period shall get automatically extended. This should be backed up by a bank guarantee for 10% of the contract value valid for defect liability period as per our proforma.

(9) TERMINATION OF CONTRACT:

The performance of the contractor will be reviewed after 45 days from the date of actual commencement of the work at site and if found unsatisfactory, UCIL reserves the right to terminate the contract with 15 (fifteen) days notice as per discretion of UCIL without assigning any reasons whatsoever. Further, UCIL also reserves the right to terminate the contract at any point of time with 15 days notice as per the discretion of UCIL without assigning any reason.

(10) PAYMENT TERMS:

Contractor shall be paid as per the following schedule duly certified by the Engineer-in-charge of the contractor bill:

Payment shall be made within 30 days after submission of all documents related to bills and certification from Engineer In Charge

(11) VALIDITY OF OFFER: The offer should remain valid for a minimum period of 180 Days from the date of opening of the technical part. The Tenderers shall not be allowed to increase, amend or withdraw his tender within this period and if he does so, the earnest money deposit may be forfeited.

(12) PERIOD OF CONTRACT: The contract period shall remain valid for a span of 4 months from the date of order issued in GeM. Site mobilization shall have to be done within 20 days on receipt of LOI/WO indicating contract price of the work. However, date of actual start of work shall be fixed by UCIL as per the site prevailing conditions.

(13). EXTENSION OF CONTRACT:

The contract period may also be extended up to 2 months beyond the stipulated contract period, if so deemed fit by UCIL and agreed by the Contractor . If so happens contractor shall have to work on the same terms & conditions and price of the contract without any escalation.

8. Seeking experience from specific organization / department / institute only or from foreign / export experience.

9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
