- a. **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences

ces whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.

- b. **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). In case after erection and commissioning, taking over is delayed beyond 90 days after commissioning for the reasons attributable to the Purchaser then balance payment of above 5% shall be released against Bank Guarantee of equivalent amount valid for 12 months.

- c. 5% of the contract price specified in Price schedule Of the Erection & Commissioning value including 100% taxes and duties (excluding GST) shall be released upon issuance of Final Acceptance Certificate.

- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
